Unto their Imperial Majesties and the Imperial Estates of Adria does Sir Angus Kilshannig, Imperial Minister of Arts and Sciences give the Report the July Meeting.

To Begin, I am Pleased to announce that almost all chapters save for Vingulf and Brandenburg (No Arts Minister)in the Southwest, all Chapters in the Northwest ,and all Chapters in the Northeast save for Cambridge are up to date in reporting. In the Southeast I have only received regular reports from Constantinople.

For Banner War 2009. In the Northwest there were two Masterworks Awarded. One was to Sir Elric for his Period Pavilion, and the second was awarded to Dame Gwendolyn for her embroidered, fur lined cloak with embellishments. Dame Seraphine was awarded a Tournament Win for her Little Morsels.

In the Southwest there were a total of five Masterworks announced, though after consulting with Imperial Rolls Minister only three were actually Awarded

One was to Mary Donna Del Moore for her Venetian Ensemble. The Second was awarded to Sir Michael Sinestro for his Original Ballad, and the third was awarded to Squire Dagian Kokesch for her Strawberry Tart. Tournament Wins were awarded to Dame Maedb Hawkins for her Pater Noster Beads, and Dame Margarita Dubois, for her Butterfly Hennin. There was an appeal of a score that was ruled valid upon review. As the score sheets were handed out at the end of the war do to the lateness of finishing the Arts, the re-judge will be done in the appellant's home chapter at the next event, and the score sheets and results will be sent to this office to forward to the Imperial Crowns and Rolls office to update Banner War Rolls if Necessary. I did not receive reports from Banner War Northeast or Southeast.

The New Form and Judging Guidelines have been out for two months nowand we have seen feedback both positive and negative, We have also heard both positive and negative feedback to the online judging collegiums being offered. These are a good idea and should be pursued cautiously in the future. The main problems that I have heard id the time difference from coast to coast can make scheduling a bit difficult for all, however with both planning and multiple collegiums across a broad range of times, this problem can be easily handled. We shouldn't let online Collegia completely take the place of in person ones either. There is something valuable gained in a face to face class that cannot always be communicated through the ether.

I have also sent the Arts and Sciences Manual update to their Imperial Majesties for final review to be placed upon this agenda for your review. In it you will find the non-judged arts rules that the Estates approved in 2007.
