**Chancery Note:** A vote of Yes on this item will remove CRB2 from this agenda as no Chapters are petitioning for advancement at this time.

Due to the continuing Adria shut down because of Covid restrictions, Their Imperial Majesties are requesting that no Chapters be reduced in status for the 2021 voting cycle.

## CRB3. Consideration of Bids for Database and Website Improvement.

After some discussion and speaking with a representative from Masheenist, Dame Mira Angel moved to table the matter pending more in depth Requests for Proposal. Motion was seconded by Dame Moira. **Motion Passed** 62-26-1. Request made by Sir Talin to discuss CRB3 at conclusion of meeting.

To the Imperial Estates.

In keeping with with previously advised committee formation as well as the more currently noted minutes regarding collection and review of bids to update the database/website for the Adrian Empire, we present the following two bids. We feel that the bullet points as noted in the 2019 agenda have been met and ask to move forward to resolve the issues presented primarily to the Rolls and Steward Offices with the issues of the database current system.

Both bidders have had complete access to the database as well as the website and PHP programs. They are aware of the requirements noted in the original agenda item and need for future expansion to accommodate a wish list of the various offices involved in the website. Both bidders feel they are equally capable of providing for current and future Adrian Empire website needs.

Both bidders are aware that there is currently discussion on the DB committee.

Both bidders have requested a level of anonymity until issues have been resolved. This is to avoid side conversations that may be detrimental to the project.

We do ask that the Imperial Estate Holders understand there is a difference between Database information and Website information. There is a "wish list" being formulated as to what website items are desired which is easy to extrapolate using code language. The database itself has been functioning since early 2000s but does need to become a web based application with some additional functionality and updating. This has been discussed with both bidders.

Bid 1 is from a company called Masheenist. Bid 2 is from a company called Element. Full name disclosure is available upon request.

It is believed that the author and sponsors of this agenda item are leaning toward the bid provided by Masheenist. While they are the new bidder, as Element has been in the bidding process since the origination of this conglomeration (3 years, duplicate bids), Masheenist is most Adria friendly, most responsive and more cost effective due to a prior member relationship and desire to "give back to the organization".
