## I. Statement of Purpose

The “Frie Companies von Lagersuufer” is a mercenary company within the Adrian Empire. Its purpose is to encourage participation in the Empire through engagement of contracts of service in both combat and arts. Additionally, its purpose is to have fun!

## II. Domain Status

It is the intent of the Lagersuufers to be governed by our Domain laws and by the laws of Adria. We submit ourselves to the authority and protection of the Adrian Empire. We have met the minimum requirements for Domain status as defined by Adrian law. (*note: Domain Status was conferred by HIM Lord Wright Brentwood in March 2005*)

## III. Name

The Name of this Domain shall be the “Frie Companies von Lagersuufer”. This shall include all division names including, but not limited to, “Lagersuufer Mercenary Companie”, “Lagersuufer Engineering”, “Lagersuufer Productions” and any other known or future use of the name Lagersuufer.

## V. Membership

A. Membership: Membership to the “Frie Companies von Lagersuufer” is by invitation. Prospective members must be a paid member in good standing of the Adrian Empire. Current members of the Companie may recommend new members. Petitions for membership to the Companie may be submitted by any qualifying member of the Adrian Empire. These submissions shall be reviewed by the *Companie Capitano*. All memberships must be approved by the Capitano and Officero Politico and must garner no objection from the current membership.

B. Revocation of Membership: Membership may be revoked by recommendation of Companie Capitano and/or Officero Politico. Any member may request revocation of a membership with cause. All requests will be reviewed by the Capitano and Officero Politico.

C. Retirement: Companie Members no longer interested in participation may retire from the Companie for any reason at any time.

## VI. Rank

- A. Capitano – Shall be the overall head of the Frie Companies. It shall be the responsibility of Capitano to coordinate activities with the companie and keep records of the companie assets.
- B. Officero Politico – Shall be the overall dealmaker in all matters of Lagersuufer transactions.
- C. Avvocato – Shall be the interpreter of the Companie rules and shall advise other officers as needed.
- D. Centurion of the Practorian Guard – Title granted to all Lagersuufers by his Royal Grace, King Reilly, Earl of Lincoln of the Kingdom of Esperance.

## VII. Children

The Companie is a family group. Parents and their supervised children are always welcome at Lagersuufer activities.

## VIII. Codex

- A. Lagersuufers shall always act with honor on and off the battlefield.
- B. Lagersuufers shall take all blows on the field of combat.
- C. Lagersuufers shall not ask for quarter, nor shall they give it.
- D. Lagersuufers shall observe chivalry in tournament fights.
- E. Lagersuufers shall not give the enemy any advantage in war.
- F. Lagersuufers shall only fight for profit or honor.
- G. Lagersuufers shall only engage other Lagersuufers when there is no one else left to fight.
- H. Lagersuufers shall put the Frie Companies above all else.
- I. Lagersuufers shall obey the Field Marshal without question when on the battlefield.
- J. Lagersuufers shall strive to present a period appearance at all events.
- K. Lagersuufers shall above all remember that “It is only a game” and to have fun.
