Disqualification (Article VI.E.6)

Members entitled to a seat by virtue of rank or office whose dues are not current, are under judicial ban, or have not attended at least (2) official events in any chapter within the previous six (6) months will be denied a seat.

The membership entitled to vote at a meeting of a given body is fixed as of the summoning of the meeting. It may not be subsequently altered by any means (including expiration of dues, non-participation formation of a new Estates or change in Estate held by a given member) until the meeting is concluded with these exceptions:

- Resignation of a given member
- Judicial Ban
- Creation of a greater estate that does not reduce another greater estate below minimum membership (subject to 2/3 approval of the Estates to waive notice and seat the Estate.)

The Crown, if available, will convene the summoned Estates at the appointed time and place and the meeting will be presided over by the Chancellor, if available

Requirement for Written Proxies. (Ratified November, 2010)

Emailed written proxies must be received by the Imperial Chancellery Office by Friday evening prior the Imperial Estates Meeting, and/or presented to the Imperial Chancellor at Roll Call. If a proxy is not presented to the Chancellery Office by the end of Roll Call, the vote will not be counted.

III. APPROVAL OF MINUTES

- Approval of the minutes of the November 2010 Imperial Estates Meeting

Discussed. *Motion to add that Budget actuals be added to minutes.* Minutes approved with Amendment.

IV. REPORTS

- President and Board of Directors – **President Chris Bagnall** - reported on a brief meeting Friday evening. The meeting Minutes will be published.
Discussed state registration. There was a filing issue with NV regarding an additional license for the state. The issue has been resolved. CA issue was contact with the State to get the registration done, they were very hard to contact and get return calls from.
Banking Issues-lateness on reporting. BoA wasn't keeping records clear on responsible parties even with multiple attempts by current and past BoD Presidents to resolve the matter with Corporate Letters of Resolution. The lateness on reporting is due to BoA resistance to provide the last 2 months bank statements so our records could be closed out.
Tax Filing There was debate and the BoD recommended to the Imperial Crowns to find another accountant due to on-going issue with the current accountant service; typing errors not corrected before filings and other minor issues.
BoD page was added to the website.
- Chancery-Sir Polonius -No issues to report. No Charges pending. All Manuals are updated and posted. Prince L'Bete stated the Lex Adria needs to be redone and the photo of the Combat Field was removed from the Combat Manual.
- Rolls-Dame Etaine-The IP is back up and running. Dame Etaine expressed her appreciation to everyone who turned their events in to the Imperial Rolls Minister for data entry during this time. Notification: Dame Felicia has a debilitating illness, but still working on conversions. Please be patient.
- Steward -Dame Rosa –Please see Stewards Report addendum
- Sovereign of Arms- Prince L'Bete -IM's have scanned all existing form to disk. We will now accept scanned forms with a hand written signature, not computer generated signature. By end of reign will be all digital. Heraldry showing up on the web site now on rolls page.
- Joust and War – King Puck- Sir Wot is still working the "On-Line" combat test. Imperial Banner War Scenarios are being finalized and will be published next Monday. Not receiving many Local Minister Reports.
- Arts and Sciences- Dame Shahara- Due to bad weather especially in the North, many events have been canceled or postponed and the local ministers are advising of such. There are a few chapters who have not reported. Imp Minister advises she is promoting children's submissions for Banner War and requested assistance from the Crowns in this promotion.

- Archery -King Nikademus- Reports that some northern subdivisions had to cancel archery due to inclement weather. Some subdivisions are not reporting. Postal shoot scores are available upon request.
- Physics-See Physiker Report Addendum
- Office of Publishing (includes Imperial Webmaster, Chronicler, etc.) – Sir Terrin-White lists are being corrected. SoA is working on images to be included in the site for Chapters and members.

Discussion on Minister Reports –

Dame Margarita asked if the Ministers can post non-reporting list with the Meeting Minutes. The Imp Crowns advised it would be made available upon request, but not posted with the Minutes.

There was a request from Dame Genevieve for a web page without the photo's and color graphics for phone Use.

There was a request to do away with the White listing due to all the issues it creates. Sir Terrin explained the White list is a security feature and that solutions for this are minimal, but they are researching all technical issues.

Sir Baine requested all Minister Reports be added to the Meeting Minutes.

V. CROWN BUSINESS

Crown Report – Topics: Web Site updates; 25th Anniversary Book; announcement of the next IEM in Newark, New Jersey July 16th and 17th; IEM and Coronation will be in Denver, Colorado, November 5th and 6th; Banner War locations announced; a potential external audit is pending; the creation of the shires of Lancaster in North and South Carolina and Carn more Dearg in Georgia; a Charter amendment to Brunico, elevated to a Duchy; elevation of Bisquia to an Arch Duchy; there are 1314 members in Adria; a possible Imperial Order dedicated to Renn Fighters (working with Dame Pandora on this.). The Crowns will be soliciting aide from the Chapters on this. It is a work in progress to be presented at the next IEM in July. Due to issues with spam email messages, the Emperor and Empress @Adrianempire.org are not working. Their personal email addresses have been published. Please use them if you need to contact them. No Questions for the Imperial Crowns.

TIM's are requiring ALL Crowns, Chancellors, Rolls and Steward's offices to report to their respective Imperial ministers on a monthly basis. (Even if there is nothing to report, please submit that there is nothing new.) All other offices are at the discretion of the respective Imperial minister.

CRB1. Imperial Budget 2010 – 2011 See Imperial Budget Addendum

Discussion on Imperial Budget 2010 – 2011

Imperial Crowns advised of a couple write in changes – At Imperial Coronation, the \$2,000.00 wasn't transferred over to the Estimated Income column and the "Allowance for Bad Debt (Returned Checks) delete the Estimated Income of \$250.00. That is not income, but recoup fees.

Question – What is the Special Events? Response – for the 25th Anniversary Jubilee Feast.

Question – Exactly who is authorized Imperial Travel? Response – Imp Crowns, Chancellor and Steward.

Question – What do you plan for fund raisers to recoup funds for the Imperial Travel? Response – There are a couple of fund raisers in the works to include the 25th Anniversary Books.

Terre Neuve motioned and Second to separate the Canadian War from the budget. Yes – 12, 6 – abstain, motion failed.

Albion motioned and Second to approve as a tentative budget to be revisited in July. Yes-13, 38 abstain, motion failed.

Motion to approve the budget as a whole with the amendments. Approved by voice vote. Passed

CRB2. Charter Amendments

Restated Charter changes and amendments given during Crown Report.

CRB3. Ratify the Appeal of the membership revocation of Sir Santos (Sam Cessario)

(Chancellery Note: Section 1 was voted upon and passed at IEM Nov, 2010)

Motion by Prince Nikolai: That Sam Cessario attends 52 weeks of anger management, letter from licensed mental health professional stating that he is a low risk for re-offense.

Sir Thomas researched available courses in CA, AZ, NV. No 52 week courses are available.

– Motion to refer back to the BoD was made and Second. Yes – 43, 9 abstain, motion failed.

Albion motion and second to approve Santo to attend any Crown event, but no Canton events. Friendly amendment made to include all fairs. Discussion halted.

RECONVENE 3:11

Resume CRB 3 - reread the motion. Santo can attend one (1) monthly Crown Tournament event to exclude Cantons, Imperial Events, and Overnight events.

Request for more clarification – Estates voted no attendance at fund raisers and no local estate meetings.

CRB 4. Modification to Marshall's Manual to Allow for Online Combat Tests.

The office of the Minister of Joust & War has been play testing online versions of the combat tests. This proposal would modify the Marshall's manual to allow for online testing and grading.

– Motion and Second to Table Yes – 26, motion failed.

Motion and Second to Discuss.

This is an alternative mode of taking and submitting tests. Manual, hand written tests will still be accepted.

Motion and Second to approve Yes – 93, motion passed.

Motion and Second to Discuss, approved Motion and Second to Split the vote. Failed. Motion and Second to approve Yes – 86, No – 53, abstain 1, motion passed.

CH4: Rewording of Imperial Estates Writ #27 (requires Simple Majority)

Renaissance Faires and Mundane Contracts

Current: All Renaissance Faires involving more than one chartered subdivision of the Empire, regardless of where they are located, will be considered to be Imperial events and shall require Imperial sanction.

Negotiations regarding them will be handled by the Imperial Crown or Their appointed autocrats.

Replace with - All Renaissance Faires that are pre-arranged for multi-chapter participation will require notification to the Imperial Crowns for sanction. The Imperial Crowns, or their appointed representative, will be responsible for negotiations. All contracts must be presented to and approved by the Imperial Crowns.

Commentary: Chapters attend and participate in numerous Renaissance Faires across the country. Dame Shahara can attest to not being notified, or receiving requests for the sanctioning of the Renaissance Faires held during her reign with exception of National Steel. AZ, CA, FL and NV among others have numerous faires within their Chartered lands and some are very small and attended by only a few members. Often, it is not known if other Chapters will be attending a Renaissance Faire until time of the faire. Should every Faire be considered an Imperial event? And if so, are the participants eligible for a double dip point because it is

considered an "Imperial event"? Sanctioning of small Faire events should be at the discretion of the local Crowns except for pre-arranged multi-chapter participation events such as the National Steel Invitational. Also, this change will accurately reflect the requirement of the Imperial Crowns to review and approve mundane contracts for faires.

Motion and Second to Discuss, approved. Want to change the word sanction to approval and change participation to autocrat. Motion and Second to approve as written. Yes -110, No – 44, 5 abstain, motion passed.

Final Verbiage: - All Renaissance Faires that are pre-arranged for multi-chapter Autocrats will require notification to the Imperial Crowns for approval. The Imperial Crowns, or their appointed representative, will be responsible for negotiations. All contracts must be presented to and approved by the Imperial Crowns.

VII. OLD BUSINESS

Motion and Second to limit all discussions to 10 minutes. Approved

OB 1. Amend Imperial Estates Writ 1, III. B.2. (Requires a Simple Majority)

For the purposes of the Adrian Empire a primary source is:

- An un-translated publication from the period.
- A photograph or photocopy of an actual publication, manuscript, quote, item or picture from the Period.
- **Transcriptions or translations from a published authoritative source.**

Comment: Passing this amendment will also include updating IEW 37 judging guidelines, terms section. IEW 37 defines an authoritative source as; "An authoritative/reliable/credible source is one that is reviewed and reputable. Publishing does not make something authoritative; the Internet does not make something non-authoritative. Look at the academic and background credentials of the author to help gauge the authority of the item. Look at Authority as independent of primary, secondary, and tertiary sources. A primary source can be non-authoritative; a secondary or tertiary source can be authoritative. Use caution when reading the Works Cited page; a primary source such as a picture may have been found within a non-authoritative source."

Commentary: When putting forth the Judging guidelines and incorporating transcriptions and translations as a non- Primary source we did our best to hold true to what a Primary source truly is in the mundane world. I do not dispute that many great institutions "Allow" them as such. Such an Allowance still does not make them a defined Primary Source. Yet this ongoing debate has been very non productive and I am sure feeding into it will be the same result.

The true question is what does Adria want a Primary source to be? I had hoped that after close to two years the protagonist during my experience would step up like was stated. So based on what I have heard and read from the membership I present this proposal. I have never been personally tied to either option. I just want to see the arts moving forward with clarity and unity, instead of conjecture and hearsay.

OB 2. Amend Article VI. A of Lex Adria (Requires a 2/3rd)

ARTICLE VI: MEETINGS OF THE GOVERNING BODY

A. IMPERIAL GOVERNING BODIES; SUMMONING MEETINGS

The governing body of the Adrian Empire is the Imperial Estates General (Which consists of: the Imperial Crown and the self governed Chapters of the Empire being Kingdoms, Archduchies and Duchies. As a member of the Estates each shall maintain one representative vote within the governing body. Shires being entry level chapters do not have votes; such are represented by the Imperial Crown. Imperial Peers shall be considered non-voting members of the Imperial Estates, having a voice and the ability to present items to the Estates for

consideration.

Comment: 1. this is not intended to change the Estate General of Chapters. What is Law could still stand.

2. Imperial Estates Writ#18 may need to be amended to reflect change

3. Other sections under Article VI may need to be clarified a little more specific between Imperial Estates and Estates General.

Commentary: *I could fill this agenda with at least five pages on this one topic. Instead I will just list a few of the “Why” in what I am proposing and will be more than happy to discuss in more detail on the Imperial Estates Board.*

1. *I do not believe our current structure will sustain positive growth. I believe we are around 150+ votes with around a 1200 membership (average) if over the next five years we grew 1200 hundred more, we could easily be looking at 300 votes.*

2. *Aside from personal vote participation tracking. We have no way to verify the population of Estates.*

Example: a March which has 50 members. Do we truly know that fifty members are freely a part of this estate? Or are we just assuming so because the chapter may have 50 members, so it is possible.

3. *The desires of the few are out weighing the needs of the many. I believe the personal votes are currently starting to exceed the estates votes. While it is wonderful to see such accomplishment and longevity of membership rise. If such continues (which I am sure we all want members to stay) the individual vote s will overwhelm the estates to such a point that Kingdom, Duchies, estates ect... will have no importance among the Estates. Example: My Lady and I are both K3s, our support or opposition is equal to that of two marches representing 100 people. So theoretically at today’s membership, the opinion of 20 k3’s is equal to 983 members. If we do grow and manage to retain members, we are going to need an auditorium to hold our meetings.*

I will stop here with one last thing as it is getting lengthy. I was talking to a fellow knight about this proposal. He said to me “Even if it is a good idea. You don’t think people are really willing to give up their person votes and powers do you?”

I replied “I am willing.”

Prince L’Bet’e deAcmd

– Failed by voice vote. Sir L’Bet’e hopes this will get people to start thinking about possible changes for the future of Adria.

OB 3. Proposal to Freeze Memberships of Military members who are deployed or stationed overseas

(Requires a 2/3rd)

Members of the Military that are Active Duty or Called into Active Duty that are deployed or stationed overseas may have their memberships frozen at the date of their deployment or reassignment of duty stations. ~~If a member wishes to have their membership frozen, they will need to provide a copy of their Orders, upon Return, to the Local Steward for verification.~~ The local steward will then forward the information to the Imperial Steward. Upon returning stateside their membership shall be reinstated with their dues being prorated for the time that was not used based on the prorated amounts on the membership form.

Commentary: *Those who serve our Country should not be penalized for missed time when they are sent overseas. This is an option for those that are overseas to be able to return home and know that their membership within the Adrian Empire is still there and they are not having to pay for a membership that they will not be able to use.*

Final, Motion and Second to refer to Chancellor to write up something to allow these Military personnel to be able to garner EP’s during furloughs. Will be Chancellor’s business at July 2011 IEM.

OB 4. Change Imperial Estates Writ 6e: Demonstration Initiations

Current Law:

The relevant Crown will determine if the service was acceptable and useful. In the case of Subdivision Rulers

and Imperial Ministers, it will be determined by the Imperial Crown. In the case of Imperial Crown, it will be determined by the Imperial Estates General. Shire Viceroy and Vicerines may award these points if each award is accepted by the Imperial Crown. DIs are granted at the discretion of the Crown and are never automatic.

Proposed Changes:

The relevant Crown will determine if the service was acceptable and useful. In the case of Kingdom Crowns, the determination will be made by the Royal Estates. In the case of all other Chapter Rulers and Imperial Ministers, it will be determined by the Imperial Crown. In the case of Imperial Crown, it will be determined by the Imperial Estates General. Shire Viceroy and Vicerines may award these points if each award is accepted by the Imperial Crown. DIs are granted at the discretion of the approving body and are never automatic.

***Author Commentary:** When a Kingdom Crown autocrats a war or a feast, the Kingdom Estates is the body most likely to know if the event was a success or not. The Imperial Crowns may attend the event, but more likely they will not, but even then, they may not be aware of any issues that occurred during the event. However, if any one particular body of people is likely to know, it is the Kingdom Estates. This is also true for the Service DIs that are covered in Imperial Estates Writ 6. Additionally, this leads directly to the Sovereignty of Kingdoms. Kingdoms should be allowed to manage themselves as they see fit. The Kingdom entity that has oversight of the Crowns is the Kingdom Estates.*

OB 5. Add to Article VI.F.1.d: Rights of the Estates General – The Imperial Estates General –

(Requires a 2/3rd)

v. Approve changing from one software package for any Imperial computer database system to another to include:

a. Rolls Database

b. Stewards Database

c. Heraldry Database

d. Any other software database system that may enter the service of the Empire.

e. This should not be construed as requiring permission for system upgrades and/or bug fixes. This is only to change the actual system itself. All software is assumed to be owned by the Estates General.

***Author Commentary:** Theoretically, the Imperial Crown could change every database currently in use to be whatever they wanted. They could even abolish the practice of using computer systems in general for database purposes. This law would prevent that and would transfer guardianship of all database systems to the Imperial Estates. Any change, other than normal periodic maintenance and software upgrades to the EXISTING software would require the approval of these Estates. Let's take the Rolls database as an example. When a new version of the client is published or the database itself is upgraded for bug fixes, which would not require approval. However, if Sir Terrin no longer wanted to perform this valuable service, the Imperial Estates would need to approve changing the Rolls Database system to Sir Madoc's database. If this item is approved, we, the Estates, will essentially be issuing an Imperial Estates Writ that authorizes a software package for Imperial Use.*

OB 6. Modify Imperial Estates Writ 33 to Remove the Limitation on Using Non-Judged Arts for Event Participations

Author Commentary: Currently, artisans are able to submit just over half (37/72 for Knight Doctor) non-judged (NJ) arts entries for EPs, with Crown and MA&S approval. I see no reason to limit this at all. There are several reasons for this and I shall endeavor to touch them all.

a) Terre Neuve has had great success in using non-judged arts at events. We have had sewing, black work, embroidery, spinning, knitting, singing and several other types of non-judged arts performed at events. This is a great way to bring the Arts to the populace. Instead of doing all the work at home, the populace gets to see the work in progress.

b) Even if someone should happen to use NJ Arts for all of their EPs, they cannot receive a Tourney Win or a Master Work for NJ entries. They will still have to submit at least the number of TWs in actual judged arts activities to progress up the ranks in Arts. Participation at a War is only via a judged entry as well.

c) A prospective Knight Combatant can theoretically show up to each event with armor in hand and receive an EP without even having to don the armor. (Only if there aren't enough people for a list, but it's possible.) This is true all the way through the Combatant Path. However, this same prospective Knight Combatant cannot gain the rank of Knight Bachelor until two tourneys are won. At least for NJ Arts, the artisan must perform at least 30 minutes of work at each event.

d) The current Rolls Database of the Adrian Empire does not have any way to distinguish between Judged Arts and Non-Judged Arts EPs. Non-judged arts have been authorized for several years now and if someone wants to challenge whether the limitation on NJ Arts has been observed for a particular person that would cause a major upheaval in the Rolls system. Even should the Adrian Rolls Database be updated to account for non-judged arts, the amount of labor required to go back and update all of the old records would be practically prohibitive.

Associate Memberships should be limited in scope and limited in length as they are paying a much lower rate than the Members of Adria as a “try me” membership.*

Additionally, there have been abuses of the Rolls System from members in Adria who have wanted to convert their points from another group after they have been playing in Adria for many years and just want to “level up”. If members have been in Adria for many years, they should NOT NEED these points.

We agree that other organizations information and length of years in medievalism are of benefit to Adria but we should not be giving away titles, points, knighthoods and such to people who have just joined Adria to see how things are in our organization. We do not receive the same in any other organization and we should limit it here in Adria so that we may retain our own culture and allow members from within to have the dignity they deserve.

Between scenarios, the arrow should be inspected for cracking and breaking of the shaft and looseness and separation of the arrowhead. Combat archers are expected to inspect their own equipment between each battle for any potential hazards.

2. Arrows

Combat arrows are fiberglass shafts with a thick *protective* tip. They are the only type of arrow approved for use in combat archery. The arrows must be made *in accordance with* ~~as described in~~ the Adrian Missile Construction Manual *or use pre-manufactured CUBB style Baldar Blunts (aka the Fathead) attached to the fiberglass arrow shaft* . Between scenarios, the arrow should be inspected for cracking and breaking of the shaft and looseness and separation of the arrowhead. Combat archers are expected to inspect their own equipment between each battle for any potential hazards.

Author's commentary: According to the manufacture's web site "Baldar Blunts have a UHMW (Ultra High Molecular Weight polyethylene) core covered by low-durometer Sanoprene that fit on the tip of an arrow. They prevent injury to persons, and therefore allow for safe and effective combat archery (CA) within the Society for Creative Anachronism (SCA)". "They come in black only. Classic Baldar Blunts are discontinued. The current style approved by the Society Marshall is the CUBB aka the Fathead. The blunts fit 1/4inch fiberglass shafts". Not everyone has the mechanical ability needed to produce a safe missile weapon. This will allow for a safe alternative being that the blunt is intended to be used as a missile weapon. CUBB style Baldar Blunts have been in use by other organizations and play tested within the Adrian Empire demonstrating excellent dependability and reliability while providing a durable cost effective product.

Report from Imperial Physiker's office

Thank you for the timely reports from the Adria physikers. I have strived to foster communication and the exchange information within the Empire to promote safety for all who participate within the Empire.

I have recommended chapters to obtain a copy of the Red Cross First Aid manual to provide a reference for physikers and first responders to assist in dealing with possible medical problems that may occur at an event. The utilization of the manual provides a guideline to remain within the Good Samaritan act. I encourage all chapters to research the parameters of the Good Samaritan act of the state where a chapter is hosting events. Each state has variations to the law regarding medical professionals. I have discussed with the physikers the need to be mindful that the primary duty is safety, assist in minor injuries, and encourage follow up when an injury occurs.

I have confirmed the Adrian Empire does not have to adhere to HIPAA act on regarding privacy of medical information. The Adrian Empire is a non profit organization which does not provide health care services for profit or maintains health records. The health professionals who practice as phyikers have to maintain health care privacy within the requirements of their particular profession.

Thank all chapters who have communicated with me. Everyone has been very positive on their service to the Empire and have been eager to exchange information with others.

2. I was unable to address the Imperial Estates after my reign because of medical issues including time where I was hospitalized.

I read the following and then answered questions:

The goal for my reign was to show the Empire the benefit that separating the Emperor / Empress positions from the office of the President / Vice President would have for Adria. To accomplish this, I led by example and to do so under the existing law, that meant running the Empire alone -- with advisors but without an Empress with which to share duties. This was not an easy way to run the Empire and I would never recommend it again, but by making this sacrifice, I showed that the Imperial and mundane duties could be performed by different individuals.

The major part of this goal, the Adrian legislation of the division of duties, was successful with the cooperation of the Imperial Estates in March of my reign. In July, legislation was passed providing additional details on how it would work. Since that time, the Imperial Estates have continued to tune the separation. Each and every Imperial Crown since has chosen to take advantage of it and had a different Emperor, Empress, President, and Vice President.

As with any Imperial reign, mine had its strengths and its weaknesses and doing the job without a co-ruler certainly emphasized any personal weaknesses I have. As with other Imperial Crowns who received their retirement titles, some Adrians were left happy, some were left angry, and most went on their way in Adria without noticing Imperial politics while the basic job of running the Empire got done. However, I am proud to be among a few Imperial Crowns that made a lasting difference in the very structure of the organization. Mine has made the lives of Imperial Crowns and BoD leaders easier than in previous Adrian history.

I ask the Estates to appreciate my efforts and support the passing of my retirement title.

I. Target Archery.

B. Lists

There are **four (4)** levels of competition in archery tournament. The Bowman's list is for those who are just beginning. **The Bowman's list has two groups: Bows and Crossbows.** The Huntsman's list is for those who are more advanced. **The Huntsman's list has two groups: Bows and Crossbows.** Refer to the Bylaws of the Adrian Empire to review the requirements for advancement to the Huntsman's list. There is no minimum number of archers required to receive a participation point for an archery tournament; however, there is a minimum of four (4) archers required per list for the winner of the list to receive a tournament win point. Requirements for advancement in rank as an archer are detailed in the Adrian Bylaws

D. Range Safety.

5. Bows Past the Shooting Line

No bows or crossbows will go past the shooting line at any time. When retrieving arrows, the bows/**crossbows** must be left behind the shooting line. No one will occupy the space between the shooting line and the spectator line during arrow retrieval. When the archer returns from retrieving their arrows, they will **not** pick up their bow/**crossbow**, instead they will step behind the spectator line and wait for the Range Master to give the okay to retrieve their bows/**crossbows**.

II. Target Archery Equipment

A. Bows

Bows will be limited to recurve, straight, semi-recurve, longbows, and single shot period style crossbows only. Bows should be made of materials available in the time-period of the archer. Fiberglass bows should be avoided, if possible. There are no draw weight limits in Bow target archery, other than those imposed by the archery range hosting the tournament. There will be a one hundred and fifty (150) pound maximum draw weight limit for Crossbow target archery. Crossbow stocks, release mechanism (rolling block, pushpin, over/under claw) must be of period style. Crossbow prod may be of wood, metal, fiberglass or combination.

B. Other Equipment

Gloves, arm guards, finger gloves, finger tabs, arrow rests, nock locators, bow rests. Cocking devices for crossbows must be of our period style. These items are suggested, but not required. It is highly recommended that arrows be carried in a quiver.

D. Arrows/Quarrels/Bolts

Arrows/Quarrels/Bolts used in tournament competition must confirm to the following specifications:

- Standard target arrow shafts must be made of wood. No fiberglass, carbon fiber, or metal shafts.
- Solid plastic fletching should be avoided in favor of actual feather or segmented synthetic fletching. Fletching of a natural color is encouraged.
- Arrows must have target tips. No hunting tips are allowed.

APPENDIX C: EQUIPMENT CARE AND SAFETY

G. Spanning

Spanning (act of cocking a crossbow) methods must be period design. This would include, but limited to: hand pulled, stirrups, belt hook, bending level, windlass, and goat's foot.

11. Crossbow Archers are only to point their bolt/quarrel towards the target. No aiming the crossbow high over the target or down at the ground,
