CRB2. Define "Member at Large"

Add to Bylaws, Article III: Members:

F. Member at Large

A Member at Large is a paid member of the Adrian Empire not assigned to a chapter per Article III.E. Member at Large Status may be obtained through the following:

- 1. In the case of special circumstances, request to the Imperial Crown.
- 2. <u>Local Crowns may request to Imperial Crown for life time members who have been inactive for over a year.</u>

Members at large are subject to the codicils, writs, and laws where they participate.

CRB3. Remove Lifetime Membership

(Requires 2/3 to approve)

Change Adria's laws to no longer sell lifetime memberships. Existing lifetime memberships will not be affected. Strike or update references to Lifetime Membership in all laws and manuals. This includes Bylaws Article III, D; Bylaws Article III, E; and Bylaws Article IV, A. Add a dated note that they were removed. Adjust the membership form to meet this change in law.


Add a new membership type called a "Campaign Membership" that is good for 10 years with a current cost of \$270.

E. Update Bylaws, Article V, Board of Directors, A. Number of Directors

The number of Directors shall be nine. Two shall be at-large Directors, who shall be elected annually by the Imperial Estates from the membership at large for 1-year terms. Each may be reelected to one successive term. The Imperial Steward shall serve as Treasurer and may serve successive terms (as this is an appointed positionby the Imperial Crown).

•••

The Board of Directors shall elect from its own membership a Vice-President and Board Secretary according to its own procedures. The President shall be elected from among the Board of Directors by the Imperial Estates at any meeting during which there be a Presidential vacancy or for which a Presidential term be concluding. The Imperial Crown(s) and Imperial Steward shall serve in an advisory capacity to the Board of Directors. They will not be considered as Directors.

Chancellor's Note: The Imperial Steward is clearly named a Director in the first paragraph and is required to be so to make the count come out as nine which was intentionally made an odd number to reduce the likelihood of a tie vote. This is the way the Board has been operating. In the last paragraph of the same section, there is language that contradicts this and is thus being struck.

B. President

The President shall be elected from among the Board of Directors by the Imperial Estates at any meeting which there be a Presidential vacancy. The term of President is fixed regardless of whether a given President is elected mid-term. Therefore, at this meeting, the Estates shall elect a President from the current BoD membership to serve until November. In November, another election for President will take place and all of those taking office in November will be eligible as well as those remaining for another year. Christina Cox and Dan Olsen have volunteered to be elected President.

CH5. Review of the Current Conversion Policy

(While no action is required, the Estates may review.)

Chancellor's Note: There has been no change in the policy in the past year and none are being proposed.

CH6. Review Imperial Crown Writ

(The Estates may 1. Adopt as Estates Writ by majority, 2. Reject the Writ by majority, 3. Leave it as Continuing Crown Writ by taking no action)

We are issuing a writ that the recognized Rawlings swords for use within the Empire are the Synthetic Long Sword (no metal fittings), The Synthetic Bastard Sword (no metal fittings), and the Synthetic Single-hand Sword (no metal fittings). Once a standard has been created, all other Rawlings designs can be compared and judged as to acceptability or not.

Minimum Synthetic Waster Standards

- Blade material: Nylon plastic
- Max weight allowed 2 lbs. (32 Oz 907 grams)
- Minimum of 4.5" (11.4 cm) tip flex with 2 lb. (907 gram) weight added
- No metal fittings or attachments (including quillian and pommel)
- No sharp edges all flashing must be removed
- Only commercially available attachments (cross guards, basket hilts, pommels etc.) Any homemade or custom parts must be individually approved by the Imperial Minister of Joust and War

Imperial Crown Commentary:

It was presented to the Empire that we felt the generic term in our manual of the blanket statement of "Rawlings type Sword", as the quantifier for authorized weapon use was inadequate. One, it eliminated any other manufacturer as well as did not take into account future modifications that could be made by the Rawlings manufacturer such as increased stiffness and metal parts

We called for a Knight's workshop to create a minimal standard to judge acceptable synthetic waster use. We came up with the list above, now part of the Writ.

NEW BUSINESS

NB1. Charter Reductions

(Discussion automatic; 2/3rds to consider; 2/3rds to pass)

All charter reductions, including Kingdoms, Duchies and Archduchies, shall be addressed and voted on by the Estates, only once per reign, at the next meeting after the renewal deadline. A subdivision may request elevation at any meeting.

Author's Commentary: Current interpretation of law is that Duchies and Archduchies are under the purview of the Imperial Crown. This changes that law.

Chancellor's Note: This would only limit the number of times per Imperial Reign (year) that charter reductions for each chapter can be originated on the agenda (to once), but if the estates choose to, they could table any or all chapters for future consideration (e.g. to grant an extension). This legislation would not prevent those tabled from being revisited on a later agenda within the same reign.

NB2. Steps to Knighthood: Rapier/Cut-and-Thrust Fighting

(Discussion automatic; 2/3rds to consider; 2/3rds to pass)

Add an additional path to K2 and K3 Combatant knighthoods with different titles:

- 1. Knight Bachelor (first level) un-differenced from standard
- 2. Knight Fencer (second level)
 - a. 18 additional Knight's list Rapier or Cut-and-Thrust participations
 - b. 5 additional Knight's list Rapier or Cut-and-Thrust tournament wins
 - c. 5 additional demo participations (involving Rapier or Cut-and-Thrust combat)
 - d. 5 additional war participations
- 3. Knight of Defense (third level)
 - a. 36 additional Knight's list Rapier or Cut-and-Thrust Participations
 - b. 10 additional Knight's list Rapier or Cut-and-Thrust tournament wins
 - c. 15 additional demo participations (involving Rapier or Cut-and-Thrust combat)
 - d. 10 additional war participations

Optional addition:

Grant the sumptuary right of a blue scarf to be worn on the Knight Fencer's or Knight of Defenses' preferred sword arm between the elbow and the shoulder.

Author's Commentary: With the SCA's addition of a Society-level peerage for unarmored combat, the rise in popularity of HEMA cut & thrust combat, and the continued issue of some combatants being unable to engage in medieval Armored combat (and thus unable to progress beyond Knight Bachelor), but very dedicated to the art of fencing and/or cut & thrust combat styles, the time has come to reconsider adding an optional STK document to the Adrian combat discipline.

This optional STK would include only points earned in Rapier combat, and would grant the same sumptuary and armorial rights as existing combat Knighthoods, but not the titles of Knight Banneret or Champion (unless otherwise earned on the traditional STK).

Chancellor's Note: I worked with the author to replace the term "Renaissance" with "Rapier" to be consistent with our current rules and manuals. Further clarification of his intent then added "Cut-and-Thrust." There may be more changes for November as he has now indicated that he wanted all non-armored formats to count including Rawlings, but as he didn't submit an update, I wasn't sure how he wanted that worded.

(Discussion automatic; 2/3rds to consider; majority to pass)

IEW-8. Classes Adopted, last amended December 2012 (Chancery).

C. There must be at least 10 people attending the class, in order for the instructor to receive a DI. This can be cumulative.

D. Each class a person gives within a twelve-month period must be on a different subject to receive DI credit.

G. Those holding the class will garner a demo-initiation point <u>when there are 10 attendees</u>. Those attending, <u>including those member(s) holding the class, regardless of whether a DI is awarded</u>, will garner demo participation points <u>that shall count in the discipline(s) in which the class was focused</u>.

III. EARNING POINTS

3. DI's and DP's

b. How DI's are Awarded

i. Being the Autocrat of a Demonstration

...

<u>All</u> Adrian members who attend, sign-in, and assist with the demonstration receive credit (called a DP, Demonstration Participation point) for their advancement towards knighthood in whatever discipline, or disciplines that they assisted with.

Demonstrating or discussing the techniques, materials, or equipment of a particular subject counts as a DP in that discipline...

iii. Teaching a Class (Giving a Collegium)

• • •

To qualify for a DI, the class must have at least ten (10) separate attendees who have signed in (this may include the teachers. If there are not ten (10) attendees, the teacher may conduct the class again and accumulate attendance to reach this goal, but it only counts as one class <u>for their DI credit</u>.

<u>All</u> Adrian members who attend a class and sign-in receive a DP. The DP shall count in the disciplines in which the class was focused. If more than one discipline is addressed, it may count in more than one discipline. For instance, if a class is taught on how to fight a particular style of combat, it counts as a combat DP, while a class taught on how to construct a period weapon that then goes into period use of that weapon, may count as both a combat DP and an arts DP. The Crown responsible for granting the points is also responsible for making this determination. The teacher is responsible for making sure an event sign-in form is filled out, that the class attendees sign-in, and that the form is turned into the Minister of Rolls upon completion. Failure to turn in the rolls paperwork for a collegium is cause to deny a DI regardless of how much other work was done.

A member may not <u>receive a DI for</u> teaching the same class more than once per year (unless it is a cumulative class). Members may attend classes as often as the class is taught and shall receive DP's for doing so. In a cumulative class, they only count toward the minimum of ten (10) attendees once.

Author's Commentary: A clarification to bring current policy in line with common understanding and promote various levels of participation in our stated mission of historical education.

GLOSSARY

Attendee – A person present at an Adrian Empire event regardless of membership status. To be an attendee, a person must sign-in on the Event Sign-in Sheet and, if there is a site fee, pay it and be recorded on the steward's sheet. Demo Participation (DP) – If a member goes to a demonstration or collegium and they participate in that event, they receive a demonstration participation point. DP's may be earned by demonstrating or discussing the techniques, materials, and equipment of a subject as approved by the Crown. The DP's are applied within the discipline that the topic pertained to. (See: III.C.3. DI's and DP's.)

APPENDIX A

Trial of Sir Dietrich vs Dame Millicent April 2, 2016

Squire Lief as bailiff Sir Warhammer as magistrate Queen Babette, sitting for Imperial Crown

Plaintiff; Sir Deitrich Defendant; Dame Milisent

Timeline: The complaint was filed within the 45-day timeline. Complaint: Conduct Unbecoming: Respect Complaint: Disharmony spreading untruthful information

Complaint 1.

In the matter of Unknightly Conduct: Respect We Find Dame Milisent not guilty.

No hard evidence was presented to show any direct disrespect towards Sir Deitrich by the evidence presented or the witness statements.

Complaint 2.

Did Dame Milisent feel threated, she says yes and as such we cannot deny the feelings. We cannot declare such wrong, as feelings are not right or wrong. Sir Deitrichs statement was one of taking some undefined action, what that action would be is left to the imagination. We have only what we as individuals put forth publically for others to judge and Sir Deitrichs statement could easily be taken as hostile. Yet we are all personally responsible for the actions derived from our feelings. In the end it is the actions based upon the feelings that come under judgement.

In the Case of Disharmony:

We find Dame Milisent guilty at the Level of an Infraction

It was stated in testimony that the sitting Crown of Esperance did not enjoin in the charge and as such the charge should be dropped. 1. It was suggested upon notice to the then Imperial Crown to the plaintiff to file the charge. 2. The Local Crown is the husband of the defendant and such was why the case went to the Imperial level. 3. We are the Crown of the Empire and do find the two actions and substantiated evidence to warrant as an infraction in causing disharmony within and without the empire.

Dame Milisent clearly stated that she felt fear for her person and her family in an Adrian Empire Context to close to 400 people. She also egged it on to be shared. Though we agree she did not invoke the plaintiff she did invoke the Adrian Empire and as such made a representation of the whole organization. Such did cause disharmony and disruption as the issue spread throughout the Empire quickly as well as caused concern by those outside of the organization. Dame Lysle statement that Dame Milisent spoke to her to the effect that she feared for her life and her children was a direct communication outside of the chain of command to the issue.

Dame Milisent's infraction is simply that she should have contacted the proper authorities, if she felt "any Form" of viable threat within the Adrian Empire Inc. Vigilante defense, breeds chaos and allowed for this very case to form. In the context of the Adrian Empire viable threats and bullying should be brought directly to the Ruling Crown who would contact the Imperial Crown, the Imperial Crown directly or the Board of Directors. At that point the member would enjoy various protections while the issue was under investigation. This specific case would not have happened. Violent and physical threats are extremely mundane issues that need to be brought to the officers of the Corporation. No matter how many times people say it, this is not a game or

a school yard. This is a corporation in the real world; "playing" is not an option when it involves mundane issues.

Sentencing:

One point. 1. Censure and apology, and act of service;

Apology

Dame Milisent must provide a written statement acknowledging her breach of protocol in relating her concerns of threat to the proper authority y. She must also acknowledgement that utilizing mob mentality propaganda without due process can be damaging to the organization and the membership. Lastly a statement not to reoffend. The written statement must be submitted to the Imperial Crown no later than September 5, 2016. Such statements may be published within the Adrian Empire's media and communication boards as well as the Empires website. This portion of the sentence shall be considered fulfilled upon review and approval by the Imperial Crown.

Act of service

Dame Milisent must spend one complete event within the Kingdom of Esperance bereft of trappings or title in service to the event. The Crown of Esperance must sign off on at least three contributions of worth to the event. This portion of the sentence must be completed by November 1, 2016. This portion will be considered fulfilled once the contributions have be submitted and reviewed by the Imperial Crown.
