### CRB1. Charter Amendments

*Chancery Note: The listing in A. and B. below is based on the Membership Summary as of the date of publication.*

#### A. Consider reducing the following Chapters in status due to insufficient numbers:

Kingdoms:

*(Requires 2/3rds to approve.)*

1. Terre Neuve 95
2. Umbria 90

*While Esperance currently has 51 members, it is ineligible for reduction due to having released lands to Auroch's Fjord in March 2017. Per IEW-46, a Chapter that releases physical territory shall not be reduced in status for one year.*

Archduchies:

*(Requires majority to approve.)*

1. Albion-Rayonne 36

3. Var Heim 46

Duchies:

*(Requires majority to approve.)*

#### B. The following Shires are being dissolved per Lex Adria Imperium, Article VIII.D.3.b.xi:

*(Notification Only; While no action is required, appeals may be made to the Estates which would require 2/3rds to pass.)*

*Imperial Crown Commentary: Members of the Shire of Murrisk have been stepping up and putting in a great deal of effort to restore their Chapter. Thus, even though they are presently under numbers, we are not dissolving the Shire of Murrisk.*

#### C. Elevate the following Chapters in status:

*(Requires majority to approve.)*

1. Auroch’s Fjord 104

*Chancery note: The Archduchy of Auroch’s Fjord has requested to be elevated to a Kingdom. Auroch’s Fjord has been chartered as an Archduchy for longer than the minimum 6 months required for elevation to Kingdom status, and has at least 100 members and a well-defined territory of geographic jurisdiction. Kingdom charters are considered equivalent to Imperial Estates Writs. Should Auroch’s Fjord become a Kingdom, revocation or amendment of its charter shall require a 2/3 vote of the Imperial Estates under current Adrian Law.*

**D. Other Amendments**

1. Dissolve the charter of Fortriu and amend the charter of Var Heim to include the mundane area of Stevens County, Washington. This proposed charter amendment will merge Fortriu into Var Heim.

*(Requires majority to approve.)*

*Chancery note: The Estates of Fortriu have requested to dissolve their charter and become a canton of Var Heim. The Estates of both chapters have unanimously agreed to this proposal.*

2. Amend the charter of the Duchy of Lancaster to release the lands within a 90-mile radius of the mundane city of Charleston, South Carolina to form a new Shire.

*(Requires 2/3 to approve as stands, dependent upon results of local Estates Meeting)*

*Chancery note: This proposed amendment has not been approved by the Estates of Lancaster as of the publication of this agenda (Estates are scheduled to meet in June). See Appendix A for petitioners’ commentary.*

*The Imperial Crown has proposed an alternative and presented it to Crowns of Lancaster and petitioners – “release the lands within a 60-mile radius from the center of the mundane city of Charleston, South Carolina. The petitioners have agreed to this amendment.*

Upon submission of all delinquent Rolls records, the ban shall be lifted and the complaint withdrawn.

***Chancery note: While several of the Chapters listed in (3) are delinquent 3 or more months, the Crowns wish that this publication serve as a warning prior to filing complaints.***

Amend the Lex Adria Imperium and to define “senior members of the Estates Minor,” for the purposes of granting Imperial Estates votes, as ruling nobles of the Landed Estates Minor. Amend IEW-18: Armigerous Rights to consistently categorize 2<sup>nd</sup> and 3<sup>rd</sup> level knights as non-landed estates. Amend any other conflicting law and guidance documents accordingly for consistency.

Article VI. A. Imperial Governing Bodies; Summoning Meetings

“The governing body of the Adrian Empire is the Imperial Estates (composed of the Imperial Estate, the Estates Royal, the Estates Major, and the two senior ~~members of the landed~~ Estates Minor from each Chapter).”

#### Article VI. I. Limitation of Votes

“4. ~~For the purposes of this section,~~ S Second and third level Knighthood shall be considered non-landed voting ranks.”

#### Glossary

“Imperial Estates – The Imperial legislative body consisting of the Imperial Estate, the Estates Royal, the Estates Major, the two senior landed Estates Minor of each Chapter.”

### **CRB3. Minimum Requirements for Successful Completion of Reign**

*(Notification of Imperial Crown Writ. Requires majority to adopt as Imperial Estates Writ. Requires majority to reject as Imperial Crown Writ. Requires 2/3 to adopt as amendment to Lex Adria Imperium.)*

A Crown shall not be awarded successful completion of reign if the Chapter’s Crown, Steward, or Rolls reports are delinquent upon completion of the term of office.

Guilty Nonfeasance – The Crown sentences apology acceptable to the Crowns for public presentation for not following up on the missing \$10,000 Certificate of Deposit beyond simply asking the other defendants if they took care of it. **Option A**, in which rapier combat points earned past Knight Bachelor can be applied to *either* the Banneret/Champion Path *or* the Fencer/Defense Path, at the option of the combatant.

#### A. Replace Article IX.D.1.e. Knight Banneret and f. Knight Champion of the Lex Adria Imperium with the following:

IX. Awards, Orders, Ranks, Titles

D. Ranks

1. Combatant Roll

##### e. Banneret/Champion Path

Points toward advancement in Combat beyond Knight Bachelor may be applied to either Path, at the discretion of the Combatant. Once an STK has been audited and approved, the points credited are “frozen” and cannot be applied to another Path.

##### i. Knight Banneret

- Participation in 18 additional Knights’ Lists (eight must be in the armored Knights’ Lists), at Crown events.
- Five additional wins in the Knights’ Lists (three must be in the armored Knights’ Lists), at Crown events.
- Participation in five additional wars.
- Participation in five additional demonstrations.

##### ii. Knight Champion

- Participation in 36 additional Knights’ Lists (16 must be in the armored Knights’ Lists), at Crown events.
- Ten additional wins in the Knights’ Lists (six must be in the armored Knights’ Lists), at Crown events.
- Participation in 10 additional wars.
- Participation in 15 additional demonstrations.

##### f. Fencer/Defense Path

Points toward advancement in Combat beyond Knight Bachelor may be applied to either Path, at the discretion of the Combatant. Once an STK has been audited and approved, the points credited are “frozen” and cannot be applied to another Path.

##### i. Knight Fencer

- Participation in 18 additional rapier Knights’ Lists at Crown events.
- Five additional wins in the rapier Knights’ Lists at Crown events.
- Participation in rapier scenarios in five additional wars.
- Participation in five additional demonstrations involving rapier combat.

ii. Knights of Defense

- Participation in 36 additional rapier Knights' Lists at Crown events.
- Ten additional wins in the rapier Knights' Lists at Crown events.
- Participation in rapier scenarios in 10 additional wars.
- Participation in 15 additional demonstrations involving rapier combat.

**B. Amend Article IX.E. of the Lex Adria Imperium as follows:**

IX. Awards, Orders, Ranks, Titles

E. Titles

- 9. Knight Champion, Knights of Defense, Knight Master, Knight Premier, Knight Warden
- 15. Knight Banneret, Knights Fencer, Knight Doctor, Knight Civil, Knight Forester

**C. Amend IEW#18 – Armigerous Rights as follows:**

II. Regalia and Modes of Address

B. Practice

12. Knight Third Level

Imperial Peer, Landed Knight and Estate Major in own right. May wear a blue belt and gold spurs. May also fly a standard. May be styled "Sir <name>" or "Dame <name>" according to gender, or may use a non-English translation. Includes Knights Champion and Defense (combat), Master (arts), Premier (ministry), and Warden (archery). Knights of Defense may wear a blue scarf on their preferred sword arm between the elbow and the shoulder.

18. Knight Second Level

Landed Knight and Estate Minor in own right. May wear a blue belt and silver spurs with a gold rowel. May also fly a standard. May be styled "Sir" or "Dame" according to gender, or may use a non-English translation. Includes Knights Banneret and Fencer (combat), Doctor (arts), Civil (ministry), and Forester (archery). Knights Fencer may wear a blue scarf on their preferred sword arm between the elbow and the shoulder.

**D. Amend IEW#13 – Cut-and-Thrust and Rawlings as follows:**

- B. Wins and participations in Cut-and-Thrust and Rawlings will count the same ~~as Rapier.~~

**G. Amend Combat Steps to Knighthood Form to Incorporate Second K2/K3 Path**

- Participation in 18 additional non-rapier Knights' Lists (eight must be in the armored Knights' Lists), at Crown events.
- Five additional wins in the non-rapier Knights' Lists (three must be in the armored Knights' Lists), at Crown events.
- Participation in five additional wars (excluding rapier scenarios).
- Participation in five additional demonstrations (excluding rapier combat).

ii. Knight Champion

- Participation in 36 additional non-rapier Knights' Lists (16 must be in the armored Knights' Lists), at Crown events.
- Ten additional wins in the non-rapier Knights' Lists (six must be in the armored Knights' Lists), at Crown events.
- Participation in 10 additional wars (excluding rapier scenarios).
- Participation in 15 additional demonstrations (excluding rapier combat).

f. Fencer/Defense Path

i. Knight Fencer

- Participation in 18 additional rapier Knights' Lists at Crown events.
- Five additional wins in the rapier Knights' Lists at Crown events.
- Participation in rapier scenarios in five additional wars.
- Participation in five additional demonstrations involving rapier combat.

ii. Knight of Defense

- Participation in 36 additional rapier Knights' Lists at Crown events.
- Ten additional wins in the rapier Knights' Lists at Crown events.
- Participation in rapier scenarios in 10 additional wars.
- Participation in 15 additional demonstrations involving rapier combat.

**Parts B. through G. as described in Option A.**

**Authors:** Baron Vanyev Mikhailovich Betzina, KPr; Dame Cryssida Blackwood of Clan McKlaine, KPr.

**Authors' Commentary:** *With a resurgence in private Western Martial Arts sword schools, the SCA's addition of a Society-level peerage for unarmored combat, and the continued issue of some combatants being unable to engage in medieval Armored combat (and thus unable to progress beyond Knight Bachelor), but very dedicated to the art of fencing, the time has come to (once again) consider adding an optional STK document to the Adrian combat discipline.*

*This optional STK would include only points earned in Rapier combat, and would grant the same sumptuary and armorial rights as existing combat Knighthoods, but not the titles of Knight Banneret or Champion.*

*This is personal for me and I know some others. I have a unique feature of my skull called a Chiari 1 malformation that could cause serious issues if heavy shock is applied to the head, and thus cannot fight steel. I know of many others that don't fight Steel due to joint and muscle issues. Additionally, some people simply love the art of fencing; some have late period personas that are legally included in our time frame, for whom Fencing is a perfectly appropriate combat style. Like Steel combat, there is a great body of both period manuals and applied research that makes Renaissance Fencing a rich and engaging lifelong hobby, and in the author's opinion, not merely a stepping stone to Steel combat.*

*This proposal is not meant in any way to impinge upon or lessen the achievements of our Knights Banneret and Champion, who are rightly held in high regard. It is meant to meet a growing need and is submitted in the spirit of equality that Adria can demonstrate so well. I hope that if this passes, Knights Fencer and Defense will build a unique culture within the order, one that complements the joy of the fight that our steel fighters personify so well.*

Amend IEW 13 to add:

**IEW-13 Cut-and-Thrust and Rawlings [and Armored Knights' Lists Equivalent](#)**

**D. A combatant shall be allowed to substitute the following to satisfy an armored participation or list win:**

1. **A cut-and-thrust or rapier participation and a pre-approved demonstration for an armored list participation:**
  - a. **The combatant shall provide a printed or electronic copy of a historical manual (and English translation) to any two of the following: any Crown, any MoWJ, any Crown Marshal, or a Knight Champion, who shall evaluate the demonstration.**
  - b. **The combatant shall demonstrate elements of the documented historical style including: at least one proper stance, the basic steps, guards (wards, blocks, ...), and strikes.**
  - c. **In each subsequent demonstration, the combatant must demonstrate a different advanced technique of a demonstrated style or an introduction to a different documented style or weapon.**

- d. The panel will determine if the demonstration is acceptable.
- e. A student completing one of the classes below shall have satisfied this requirement if the panel determines his performance is acceptable.
2. A cut-and-thrust or rapier list win and a pre-approved class for an armored list win.
  - a. The combatant shall provide a printed or electronic copy of a historical manual (and English translation) to any two of the following: any Crown, any MoWJ, any Crown Marshal, or a Knight Champion, who shall evaluate the class.
  - b. The combatant shall meet all of the requirements for an approved class except that he may have as few as 4 students.
  - c. The combatant shall teach elements of the documented historical style including: at least one proper stance, the basic steps, guards (wards, blocks, ...), and strikes.
  - d. In each subsequent class, the combatant must teach a different advanced technique of a taught style or an introduction to a different documented style or weapon.
  - e. The panel will determine if the class is acceptable.
  - f. A student taking the class may count it as a demonstration participation or part of the substitution but not both.
3. The demonstration or class combined with the participation or win may not be used to satisfy a demonstration requirement.
4. Combatants desiring to distinguish themselves as scholars of defense may style themselves as Knight Scholar Defense (K1), or Knight Free Scholar Defense (K2), or Knight Provost Defense (K3) or other historical equivalent.

*Author's Commentary: This proposal is offered as a compromise to allow non-armored advancement that acknowledges the belief that armored combat demands more from the participant. It is not creating a separate Knighthood. It is intended to be compatible with our educational goals.*

*The authors hope that, beyond passage for this item, this idea will become a part of other knighthoods in the future.*

## **OB2. Amend IEW-13 to include crossbows**

*(Requires majority to approve.)*

Amend IEW-13 as follows:

### **IEW-13. Cut-and-Thrust, ~~and~~ Rawlings, and Crossbows**

#### **A. Manual Modifications**



1. The Imperial Estates direct the Imperial Crown and Their Ministers to modify the Combat Manual to adopt weapons requirements and armor standards for Cut-and-Thrust and Rawlings.

2. The Imperial Estates request the Imperial Crown and their Ministers modify the Missile Weapons Guidelines to adopt standards for crossbow archery.

B. Wins and participations: ~~in~~

1. Cut-and-Thrust and Rawlings will count the same as Rapier.

2. Crossbow will be counted the same as Archery.

C. Lists ~~in~~

1. Cut-and-Thrust, Rapier and Rawlings

2. Bows and Crossbows

may be held as separate lists and counted at the same event pursuant to any other restrictions in the Bylaws or Writs

*Authors' commentary: Current research has shown that crossbows are legal in all 50 states but that there are restrictions on their use for hunting in most states.*

*Author responses to concerns raised in the discussion from March:*

- **Would result in several conflicts**

*If the Chancery, or Estate Holders, can provide specifics, we will gladly address them.*

- **Not equivalent to Archery, not equivalent in skill level**

*This is not a problem. Crossbows require a different set of skills, but only compete with other crossbows. We concede that they are more different than long bows, recurves, short bows, but not significantly different than separate competitions between rifles and pistols. Comparing to combat, they are more similar than shinais and rapiers or rapiers and steel. If crossbows are “easier” than hand bows, they are equally “easier” for each participant. No one will be given any particular advantage over anyone else. You can compete with checkers against checkers or chess against chess. We are not permitting checkers to be played against chess. One advantage to crossbows, that makes it more equal “across the board”, is that draw weight is less of an issue, because historical mechanical cocking (drawing) devices allow weaker crossbowmen to compete with stronger crossbowmen, as well as allowing “differently enabled” individuals to participate.*

- **Most chapters can't use crossbows in their local areas**

*We do not believe that is accurate. While you may need to go to a private range, it is already the case for any archery in some chapters. We are not saying “you have to”, think of steel combat or combat archery not being permitted in some parks. We do what we can where we can. What you can or cannot do does not adversely affect what I can or cannot do.*

- **Doesn't need another path for archery**

*Do we need 5 forms of combat with up to 7 lists/tournament (not including the Imperial Challenge)? Why do we encourage ALL historical arts and research instead of limiting it to one form? Why is ALL service recognized instead of simply one or two jobs? Because Adria is richer for it. The argument is valid, we don't NEED it, but why NOT allow and include it?*

- **Safety of learning/teaching; weapon is easily discharged**

*Yes, they are, but hand bows do not have safeties. Knowing the weapon, the concern is addressed in the training. In all the years of intermittent testing, we have been doing it safely. It is a fact of physics that crossbows are not half as powerful as equivalent draw weight bows.*

- ***The insurance company may not accept it***  
*It has been allowed. If, and when, it isn't, and for so long as it isn't, it would have to be suspended.*
- ***Crossbow is historical (target, war and hunting)***  
*Since the Roman Empire, throughout our entire historical period, crossbows were a significant weapon of war. By ignoring crossbows, we are ignoring a huge portion of the archery history of Europe.*
- ***“It has a coolness factor”***  
*Yes, it does (like steel combat, it draws a crowd, also great in parades, and as court weapons).*
- ***Internal conflict without being able to replace the manual at the same time with standards and rules for the discipline.***  
*No, because the missile weapon manual is a continuing Crown Writ and can be addressed outside IEMs.*
- ***No changing war points***  
*We concur that, that there is no compelling reason to deal with it until it is better established.*

### **OB3. Explicitly allow combined lists.**

***(Requires majority to approve.)***

**Option A.** Add the following section to IEW-13:

D. Every effort should be made to offer the opportunity to participate in all five forms of combat and all seven lists if time allows and a sufficient number of combatants are available; especially not less than shinai (for new fighters), and steel to meet the requirement for armored combat. The goal is to provide monthly participation in each path to knighthood. But, current law provides that where equal lists are allowed (e.g., Sergeants' Shinai and Rapier; Knights' Cut-and-Thrust, Rapier, and Rawlings) only one needs to be offered at an event. In interpreting Lex Adria V.E., Crowns should be encouraged to offer as many of the available tournaments as practical; however, as few as a single tournament in each discipline – arts, archery, and combat – open to both beginning and advanced participants (i.e., e.g., a single arts competition open to both Journeymen's and Knights' lists, an archery competition in either bow or crossbow where Bowmen are invited to shoot on the Huntsmen's list, and a combat list such as rapier or Rawlings where Sergeants' list participants can be invited to participate on the Knights' list) will satisfy the law.

**Option B.** Create a new IEW with the verbiage stated above ([either Option A or C](#)).

[Option C. Amend Option A as below:](#)

[D. Every effort ... armored combat. If at least four \(4\) participants' sign-up for each, shinai, rapier, and steel must be offered. The goal is ...](#)

***Authors' commentary:** This is an explanation of the tournament requirement in Lex Adria V.E. The Lex requires the opportunity to participate in arts, archery, and combat each month, regardless of those opportunities are offered at one event or spread out over several. It is strongly implied that the opportunity will be provided to both beginning and advanced participants, but it is not clear. It is widely assumed that shinai, rapier, steel bowman's and huntsman's and arts lists should, or must, be held each month, and many would add sergeant's and knights rapier and Rawlings, and cut-and-thrust to that list (If crossbow is added, it would be added to that list), but that is NOT what the law says. Previous Imperial Crowns have allowed events which only offered rapier without offering the alternative lists (Rawlings and cut-and-thrust). It is simply not always practical (for reasons of time and endurance) to hold sergeants' shinai, rapier, and Rawlings; and knights' rapier, Rawlings, cut-and-thrust, and armored (steel) combat tournaments (7 separate combat tournaments) at the same event. If crossbow is adopted, it may not always be practical to offer 4 archery tournaments lists (bowman's bow and crossbow, and huntsman's bow and crossbow) either.*

***The authors request immediate implementation if this is passed.***

***Chancery note:** If rules for crossbow are implemented as proposed in NB3 above, this paragraph would apply to bow and crossbow as well. Currently, the criteria for allowing early participation on a Knights' (or Huntsmen's) list are outlined in IEW-28: Brevetting Policy.*

***Author's response to concerns raised in the discussion from March:***

- ***Concerned with protections against the lower lists being always rolled into the higher list***  
*We have amended the language to discourage this.*
- ***It's going to crush the steel list, faster than NB1 could. Only need one list, then it would be rapier list and not steel for Knight Combat***  
*We agree that this should not be encouraged, merely that it is the law and a Crown is acting within Their authority.*

## IX. NEW BUSINESS

### NB1. Amend IEW-17 (Combat Manual C&T Armor reqs) to allow HEMA approved armor equivalents

*(Discussion automatic. Requires 2/3 to consider. Requires majority to approve.)*

Amend IEW-17.III.D as follows:

#### D. ARMOR: CUT-AND-THRUST COMBAT

All references to “steel” indicate mild steel unless otherwise stated.

*(Note: 1, 2, & 3 are unchanged)*

##### 4. Body

The body must be protected by any one, or a combination of, the following:

###### a. Buff Coat

- i. A lined medium weight canvas or denim with a 5 oz. leather buff coat, or equivalent, is required. The body protection must include coverage of the buttocks and groin area.
- ii. Extra padding or rigid protection over the kidney area is required.

###### b. Brigandine or Wisby Coat

- i. A lined medium weight canvas or denim with a coat of plates of rigid material, mounted to leather or heavy canvas, with no gap greater than 1/2 inch. The body protection must include coverage of the buttocks and groin area.
- ii. Any overlap at the sides should be the front over the back.
- iii. A heavy-weight jacket, no less than 3 layers of canvas or denim, 2 layers of canvas or denim plus sweat-shirt, or a HEMA approved jacket.

##### 5. Arms and Legs

a. Rigid elbow protection and padding are required.

b. 10 oz. leather or rigid material on the forearms or a heavy-weight jacket, no less than 3 layers of canvas or denim, 2 layers of canvas or denim plus sweat-shirt, or a HEMA approved jacket is required.

c. 1/4 inch quilted padding or semi-rigid material or a heavy-weight chausses, no less than 3 layers of canvas or denim, 2 layers of canvas or denim plus sweat-shirt, or a HEMA approved chausses covering the upper legs is required.

d. Rigid knee protection and padding are required.

e. Rigid shin protection is highly recommended.

##### 6. Hands

a. Heavy leather gloves that extend past the wrist or similar protected by a swept hilt that covers the fingers and back of the hand.

b. Rigid protection for the hand and fingers, including HEMA approved plastic sport gauntlets, is required if not sufficiently protected by the sword guard and hilt. An authorized marshal will determine if the combination of hand protection and sword hilt is sufficient.

c. Demi-gauntlets of heavy leather or 18-gauge steel is highly recommended

*Authors' Commentary: HEMA combat has demonstrated the adequacy of the above equivalents. Despite their success with swords equivalent to our steel swords used with superior semi-rigid padded 3 sport masks, we support Adrian standard requirements for face and neck protection.*

## **NB2. Clarify the Order of Precedence of the Adrian Empire**

*(Discussion automatic. Requires 2/3 to consider. Requires 2/3 to approve amendments to Lex Adria Imperium and majority to approve amendments to IEW-18.)*

A proposal to resolve apparent conflicts between Prince Nigel the Byzantine's Order of Precedence, Imperial Estates Writ 18, Lex Adria IX.E, and "Achievements in the Adrian Empire".

*Authors' Commentary:*

- 1. "Achievements in the Adrian Empire" is a document by HIH Nigel the Byzantine that does not rise to the level of law but is an important reference.*
- 2. Lex Adria IX.E is incomplete and is not intended to be an Order of Precedence.*
- 3. Prince Nigel's Order of Precedence is the most comprehensive treatment, but it has not been updated and does not address the created chapter level awards.*
- 4. IEW-18 does not have Prince Nigel's complete order, and some the awards are not in their correct order.*

Amend IEW-18 as follows:

### **II.B. PRACTICE**

What follows are the regalia and modes of address for each rank ~~in the Order of Precedence which has been registered by the Imperial College of Arms. Titles are listed in descending order of precedence,~~ with Landed Estates listed by the name of the Estate rather than its rulers.

*Authors' Commentary: Our personal preferences aside (or irrelevant), the order of precedence has not been reviewed since Prince Nigel passed. We need a policy heralds and members can follow; we further recommend that the missing awards be included in IEW-18.*

*Option B was added to eliminate the constant fluctuations in established precedence by the ongoing changes in the size of Chapters and the ranks of grantors.*
