CRB2. Combat Archery Equipment

PASSED

(Notification of amendment to Imperial Crown Writ. Requires majority to reject.) Amend CCW-2 (Missile Weapons Manual) to permit the use of commercially-available combat arrows.

Crown Commentary: After 2 years of Testing we are allowing the use of commercially available combat arrow heads that thread into fiberglass shafts. All commercially available combat arrow heads must be approved by the Marshal or Minister of Joust and War. They must contain a solid blunt that prevents penetration through the foam padding, approx. 20 mm of high density closed cell impact foam, and approx. 20 mm of open cell soft foam. The 3 sections are to be wrapped at least once with strong tape (fiber tape, Gorilla tape, gaffers tape etc.) that adheres to all 3 sections (as a safety precaution against glue separation in combat). Additionally, the first 50 mm of the arrow shaft at the point of threading is to also be wrapped with the aforementioned tape to prevent the metal collar from splintering the shaft on impact.

VIII. OLD BUSINESS

OB1. Requirements for 2nd and 3rd Level Combat Knights

TABLED

(Requires 2/3 to approve.)

If passed, this proposal would remove the distinction between rapier/cut-and-thrust and steel in terms of wins needed for advancement to 2^{nd} and 3^{rd} level knighthoods in combat, while barring the use of synthetic wasters wins toward advancement to 2^{nd} and 3^{rd} level knighthoods in combat. The requirement for participations in steel would remain unaltered.

Authors' proposed verbiage:

Amendments to Lex Adria IX.D.1. "Combatant Roll":

e. Knight Banneret

Five additional wins in the Knights' Lists (three must be in the armored Knights' Lists), either Rapier, Cut-and-Thrust, or Steel but not Synthetic Waster, at Crown events.

f. Knight Champion

Ten additional wins in the Knights' Lists (six must be in the armored Knights' Lists), either Rapier, Cut-and-Thrust, or Steel but not Synthetic Waster, at Crown events.

Authors present requested this item be tabled for a rewrite. Authors notified that substantive changes to the proposal would necessitate resubmission as New Business, and adherence to the limitation of one New Business submission per regnal year per proposal.

OB2. Removal of March IEM

TABLED

(Requires 2/3 to approve.)

Original Proposal

If passed, this proposal would remove the March IEM from the Imperial Estates Calendar, and move the required action items from March to the July meeting.

Authors' proposed verbiage:

Amendments to Lex Adria VI.E. "Official Meetings; Imperial Estates Calendar":

4. (Removed) Meeting Date, March

The Imperial Estates shall meet in March of every year, at which time they shall conduct appropriate business including but not limited to:

- a. Evaluation of the success or failure of the previous Imperial Crown's term of office as well as any prior terms of office not yet evaluated, irrespective of the length of such terms of office. (The Imperial Estates shall have the right to table consideration of any Imperial term of office.)
- b. Elect standing members to the special panel defined in Bylaws of the Adrian Empire, Inc., Article III.A.4.b.

5. Meeting Date, July

- a. Qualify and determine acceptability of Imperial candidates
- b. Finalize enough data to prepare the corporation's tax returns (if necessary)
- c. Review (at its discretion) any systems of conversion for analogous activities developed by the Imperial Crown (see Article IX.E.)
- d. Elect Board of Directors Members per Bylaws of the Adrian Empire, Inc., Article V.B.
- e. Evaluation of the success or failure of the previous Imperial Crown's term of office as well as any prior terms of office not yet evaluated, irrespective of the length of such terms of office. (The Imperial Estates shall have the right to table consideration of any Imperial term of office.)
- f. Elect standing members to the special panel defined in Bylaws of the Adrian Empire, Inc., Article III.A.4.b.

Each Chapter's Crown shall present a copy of his or her Chapter's financial records at this meeting. Attendance at this meeting shall be mandatory for at least one ruling Crown or representative from each Chapter.

Counter-Proposal

To change the Mandatory March IEM to an Optional Meeting as Determined by the Imperial Crowns. The Imperial Crowns must inform the Empire by all the normal notification methods that there will be a March IEM and which weekend it will be held on by December 1st. If the Imperial Crowns choose not to have the meeting, the funds allocated for that meeting maybe moved to either Imperial Banner War site costs or Imperial Crown War site costs, or not used at all except with notice to the Imperial Estates.

X. DISCUSSION ITEMS

Discussion of a letter from a member to the Board of Directors regarding the scope of the Adrian Empire.

- Discussion of inquiries from members about personas representing people from other cultures within the same time period.
- Does the Adrian Empire exclusively represent Western European culture?
- Point regarding that during the time period even those from other cultures who were also going to participate in the tournament and the nobility would have adapted to the culture that they were participating in
- For those who generally stayed in there "home cultures" style and practices they would not have been participating in the practices of the nobility- they would have potentially been slaves, or not treated even as decent human beings which is not something we would encourage for our members
- Reminder to making sure that we are not pigeon-holing members into a certain character due to their mundane culture and status- we are all playing a game and can chose whatever persona we desire.
- If you ever see someone being treated unfairly due to an idea regarding their mundane culture please advocate for them if they are unable to advocate for themselves.
- We should remember our organization is built upon being a historical education society who also participates in activities such as archery and combat, not a combat group with a little history thrown in.
- Concerns about maintaining the scope of Adria while also not putting too many limits on the populace.
- Possibly changing the description of the scope of Adria from "significant influence" and replace with words such as; documentable portrayals of the norm.
- Try to keep the scope simple- lets not overcomplicate it
- Changing the scope would be across the website, new member guide, hospitaler manual, and also the Lex (this one would require a change of law)
- Goal to make the message consistent across all layers of communication and to improve clarity.
