## APPENDIX C

"The intent of this document is to detail expected maintenance, programming and update of the adrianempire.org website. This is a synopsis of the developing rfp document we will present during the BoD report at the November IEM and some accompanying goals. As we understand things: The primary desire is that the estates wish to keep and enhance existing functionality and the basic structure of the website while exposing and eliminating server-side socket errors. Uncover and expose possible client-side socket errors and which browser settings may be set to help eliminate them. Required website enhancements: Add fields and maintenance capabilities for rolls entry for the description and reporting of Crossbow (Archery) and Synthetic Sword (Combat) disciplines. This includes the addition of qualification testing and results along with adding rank and steps to knighthood to the display(s). Enhance rolls entry to include these two disciplines. Add functionality for ease of use. This initially includes expanding the member selection screen to reveal a "Dashboard" from which an authorized minister may maintain all pertinent information for a selected member from one screen, based on the authority level of the minister's office. This includes steward's info, persona, rank, station, titles, armory, orders and awards. Enhance all maintenance screens so that data may be added and changed but never hard deleted. A "Soft delete" flag is added to all data so that it may be examined and recovered in the case of an error or other incident which may cause data to be removed from view/report. Upon a change to a member's data, a "History" record will be created for each transaction. This history record will contain the date, time and user ID of the minister/member making the change. A history screen will be created to show the changes made to any members data. An armory maintenance facility shall be accessible from the member's "Dashboard" screen and will be enhanced to allow the selection (but not added/changed or soft-delete) of a "Main" device and subordinates. Each armiger is allowed to sequence any or all of their six allowed registered items. Estate heraldry shall be sequencable (but not added/changed or soft-deleted) by the currently seated estate holder(s). The Emperor/Empress shall have a maintenance facility where they may appoint or remove their ministers. Online email addresses must be obfuscated for the privacy of these ministers. Future enhancements may include but are not limited to: Estate eligibility reporting for the Chancellory. A chapter maintainable calendar of events. Site Logistics/Scheduling for Imperial Ministers of War, Arts and Sciences/Archery/Crown Marshal Hosting/Domain: Control and access to the domain and web host shall be turned over to the Steward of The Adrian Empire inc. and additional ministers such as a webmaster and database administrator. This information has been requested but as of this writing has not yet been turned over. Hosting/Domain accounts shall be monitored by the steward and maintained by the webmaster. Moving forward, the BoD representative and webmaster in conjunction with the steward shall research and procure web hosting and domain ownership. There are many hosts who will provide free hosting for a 501c3 organization and we are researching those packages now. The detailed and properly formatted RFP will be presented at the November, 2021 IEM as a part of the BoD report. If the estates approve the bidding process may then begin. The goal is to have a viable bid on the table before the March, 2022 IEM. Please report errors/omissions and enhancement requests to Sir Coda"
