



The Adrian Empire



Gabriele and Callon, by the Grace of God and Will of the Estates, Empress and Emperor of the Catholic and Sovereign Empire of Adria; Queen and King of Aleon, Navarre, and Pembroke; Duchess and Duke of Annelynerose, Brandenburg, Brittany, Calais, Isle-de-Fleur, and Snowden; Baroness and Baron

of Isenwold, Grenfeld, Hanover, and Lyon; Lady and Lord of the Outlands and Islands; and Sovereigns of all Their Other Lands and Territories, to Their Patriarchs, Pontiffs, Archbishops, Bishops, and Clerics; Queens, Kings, Princesses, Princes, Duchesses and Dukes; Contessas, Earls, Vicereines, Viceroyes, Viscountesses and Viscounts; Champions, Doctors, Premiers, and Wardens; Justicars, Sheriffs, and Governors; Knights, Masters, and Ministers; and all Their faithful subjects:

Greetings,

Be it known to all to whom these presents come that We, Gabriele and Callon, Empress and Emperor of all Adria, do hereby grant this Amended Charter to the Kingdom of Terre Neuve according to Our Laws and Customs, as amended by the Imperial Estates in July anno ludus xxxviiij, being 2024 in the Common Era.

We do hereby charge Queen Gunborg Andersdotter and King Brunulf Hjalmarsson, the Royal Crowns of Terre Neuve, with this land, and reaffirm unto them the following powers and responsibilities:

To report to Us on a regular basis on the State of the Kingdom. To appoint a Minister of Rolls, a Steward, and any other ministerial position as is needed, each of whom shall report to their corresponding Imperial Minister at the intervals specified by that Imperial Minister. To represent the Kingdom unto the Imperial Estates. To create and oversee Estates within the boundaries of the Kingdom. To hold demonstrations, events, and meetings in accordance with the Bylaws of the Empire. Kingdom Codicils and Writs must be reviewed by the Imperial Crown for conflict with Imperial Law. All these conditions will be in accordance with Adrian Law & Custom.

The Royal Crown shall enjoy all rights accorded to Monarchs. The Royal Crown shall remain in office until the regular Royal Crown War, the Royal Estates deem fit to replace them, the Kingdom petitions for reduction to Ducal status, the Royal Crown themselves decide to retire, or the Kingdom fails to retain membership sufficient for or otherwise meet the criteria for Kingdom status. All these conditions will be in accordance with Adrian Law and Custom.

We, according to Our Laws, do hereby fix territory of the Kingdom of Terre Neuve to be the entirety of San Diego and Imperial Counties in the mundane State of California. It is also sworn, both on Our part, and on that of the Estates, that all the aforesaid shall be observed in good faith, and without any evil intention.
