~ Rules & Rulings ~

The following is the FINAL JUDGMENT OF APPEAL from the Imperial Sovereign of Arms

Since & since before my having assumed my mantle of Office, as the Imperial Sovereign of Arms, I have been requested by the Crown of Pembroke, to investigate the validity of the ownership of the Arms of the Canton of Pembroke, currently owned by the Kingdom of York.

In addition, the Crown of Pembroke requested of the Transfer of Subdivision, for the Arms of the Barony of Canterbury, House Wessex, House Orleon, House Bordeaux, House Luid heag Taigh & Ship Angellus, from the Kingdom of York to Duchy of Pembroke.

It has been reported to me, that this issue has been originally submitted to the previous Imperial Sovereign of Arms, Sir l'Bete & decisions have been rendered & reported. As this has been presented to me, it is safe to assume that the presenter is appealing the decision rendered & reported.

After closer investigation of this appeal, I have decided the following:

- (1) In regard to the Arms of Estates Minor (Houses, Baronies, Counties), any request of the Transfer of Arms should be made:
 - a. not by a Crown of Estates of their Subdivision, but by the Sire(s) and membership requesting the transfer of Arms for their own Estate;
 - b. in writing;
 - c. signed (original signatures only; no photocopies or scans) by the Sire(s) of the Estate(s) requesting the transfer;
 - d. signed (original signatures only; no photocopies or scans) by all members of the Estate requesting the transfer;
 - e. mailed via post to me personally, at: Gy. G. R. Dioguardi, Sixteen Sandy Court, Port Washington North, New York 11050-1736.
- (2) In regard to the Arms of a Canton:
 - a. arms of a Canton, belongs to the Subdivision it was originally registered to;
 - b. permission of the Crown, for the release or transfer of the arms which they were originally registered to, as in 1(b) & (d) must be directed to me personally as in 1(e);
 - c. arms registered, to any individual or territory, can be redesigned, used or not used at will of the person or territory they are registered to.

These are my decisions. The Armorial & Ordinary of the Imperial College of Arms will remain intact until such time as I receive the documentation(s), specified above, as in 1(e).

According to the **Heraldry Manual** (amended July 2008), **Section 5.XIII.4.b:** *"The Imperial Sovereign of Arms shall have the exclusive right to resolve conflict of armorial devices submitted by the membership, Estates, and Domains of the Adrian Empire."*

IF... the Sire(s) of the Estate(s) in question send me their Request of Arms Transfer letter as outlined above,

THEN... notification of the Transfer of Arms will be published in the Letter of Registration & Return.

IF... no letter(s) are sent to me, to & as specified in 1(e),

THEN... no transfer(s) will be made.

IF... falsified letter(s) requesting the Transfer of Arms are sent,

THEN... charges will be filed for court proceedings.

After this point, NO APPEAL WILL BE ACCEPTED on these topics.
