A bordure counterchanged.*

Returned for redraw; non period depiction. Silhouette of charges are not accepted.

CASHEL

Gules, a chevron between two chalices and a maltese cross Or.

Conflict: Jehan Alexandre Michel

Gules, a chevron or.

Commentary; One could easily think that with the two types of additional charges would count as 2 CD's. Yet this is not the case. The "Primary" charge and field are unchanged. The "single" addition of a group of charges counts only as 1 CD from the original arms. Suggestion; Perhaps a permission to conflict could be attained or some difference made to the primary charge or field.
