**Letters of Registration and Return (LoRR)**

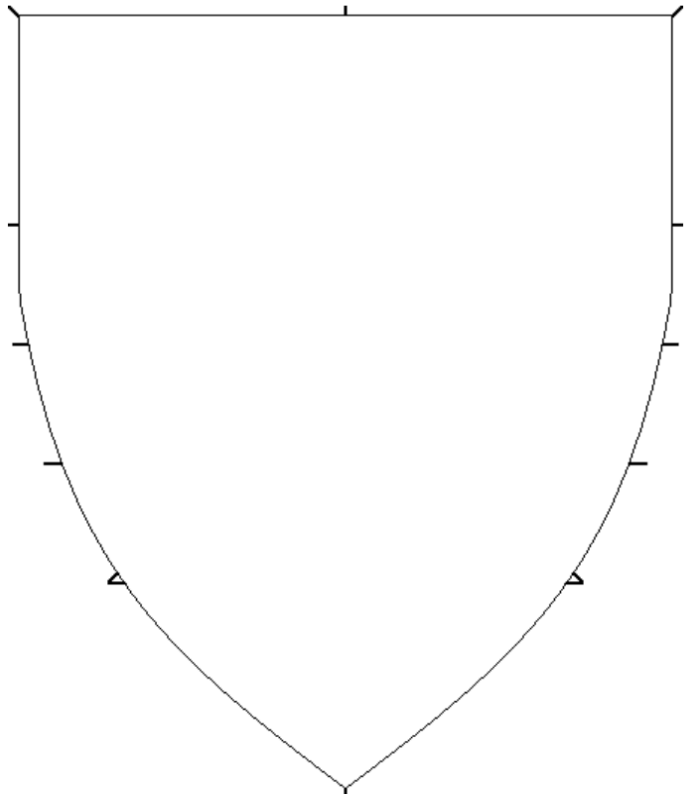
*A LoRR is an official document containing rulings made which concern the heraldry of the Empire. All rulings should be made within 90 days of a presentation being submitted to the Imperial Sovereign of Arms (ISOA). Within this time the proposal for a grant of arms will be checked against the armorial/ordinary for conflict, violations of the guidelines, complexity and blazonry.*

**In Process Vs. Official**

(Heraldry Manual 2016 Section 1: Registration I. REGISTRATION PROCESS  
A. IN PROCESS VS. OFFICIAL)

*A presentation is considered "in process" when it has been given to the local Minister of Arms and will not be considered "official" and eligible to be displayed until registered by the Imperial Sovereign of Arms.*

- 1. This ruling applies directly to the formation of Chartered Chapters, Estates and Domains.*
- 2. The eligibility of display ruling does not apply to personal arms*
