Instructions for filling out the Adrian Combat Qualification Card

This card is intended to be carried by the combatant and presented to the list officer prior to signing up for the list and a tournament or war. The list person is expected to check the card and only allow the combatant to sign up for the combat types in which he is qualified. This card is filled in by the qualifying marshal once the qualification test and safety demonstrations are completed. Only authorized marshals may qualify combatants. *Marshals signing this card are responsible for confirming that the combatant being qualified has demonstrated that they are safe and knowledgeable of the rules for that combat type or weapons form.*

To Print Card: The card was designed to be printed on a standard (2" x 3.5") business card stock such as Avery 8371 or 8571 and is double sided (printed on both sides).

|----------------------------|-----------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------------|
| Game Name | Print the game name of the combatant. |
| Legal Name | Print the legal name of the combatant. |
| Issued by | Print the legal name of the qualifying marshal. Date of issuance. |
| Shinai | Print the legal name of the qualifying marshal. Date of qualification. This qualification includes single sword, sword and shield and double weapon. |
| Participation Dates(MM/YY) | These boxes are filled in as the combatant participates in a tournament (war participations do not count). |
| Schlager | Print the legal name of the qualifying marshal. Date of qualification. This qualification includes single sword, sword and defensive item (e.g. buckler, cloak, etc.). |
| Cut & Thrust | Print the legal name of the qualifying marshal. Date of qualification. This qualification, being an advanced form of Renaissance, includes all weapons forms available to Renaissance combat. |
| Armored | Print the legal name of the qualifying marshal. Date of qualification. This qualification includes single weapon (one handed), weapon and shield, and double weapon. |

Additional Weapons Qualifications

These qualifications only require a safety demonstration by the combatant. A combatant may attempt qualification in an additional weapons form once they have qualified for the corresponding combat type.

As this card is being newly introduced, combatants who are Sergeant level or higher do not need to fill in the boxes for participations. Likewise, those covered by the "One year rule"¹ need not fill in the participation boxes.

1. A person from another re-creation group, who can provide proof of qualification in a similar type of combat, and shows that he has been qualified in that weapon form for at least one year, may go through the qualification process for a similar combat type.
