State of the Empire

Good subjects of the Empire, as We have completed the first 6 months of Our reign, We take time now to report on the state of the Empire, Our accomplishments, and Our goals. Upon our ascension to the Imperial Throne, We have followed Our predecessors' attempts to increase communication throughout the Empire. In an effort to achieve this goal, We have encouraged regular reports coming from the subdivisions to Ourselves and Our ministers. Because of this increased communication, We have been able to make the individual subdivisions feel more part of the Empire, strengthening the Empire as a whole. This has in turn helped Us to settle many long term difficulties that have plagued the Empire. Within our first six months We have:

- Settled disputes regarding the powers of Crowns over events and populaces
- Settled the status of Sangrael while protecting the retirement titles approved by their estates
- Settled questions regarding outstanding criminal sentences of several members
- Settled presentation of the titles of Imperial Crowns
- Settled on by whom, why, and when Imperial Awards can be issued
- Settled various minors, combat, and liability issues
- Outlined fairness of ministers at Crown Wars
- Settled several inter-subdivisional members' troubles
- Settled claims from mundane persons (non-members) claiming legal rights over Adrian property and estate names.
- Resolved member-at-large issues

- Play-tested the possibility of equestrian Adrian events
- Expanded the Imperial Minister base beyond its prior limits

Archery: Range Safety

There have been a few issues brought to my attention by **Her Imperial Majesty** regarding archery safety that I must address.

Target archery can be extremely dangerous, even deadly, if conducted improperly. Range safety is of the utmost importance when shooting target archery.

1. When shooting, the Range Master or the Minister of Archery is to give the ok to shoot. **This must be verbally said**, hand signals are **not** allowed.
2. Arrow shafts must be made of wood. Arrows must have “target” tips no hunting tips allowed.
3. When a **HOLD** is called, all archers are to lower their bows, unnock their arrow from the string, the arrow is to be removed from the bow entirely, **NO EXCEPTIONS**.
4. When retrieving arrows, all bows **must** remain behind the firing line. There are no exceptions to this rule. If you don’t wish to lay the bow down on the ground, allow someone else to hold it for you, but nonetheless bows are to remain behind the firing line.
5. Arrows should be carried in a quiver. Loose clothing should be secured in some way and long hair should be securely tied back out of the way, it can be very painful and very distracting should anything get caught up in the bowstring.

6. Spectators are to remain 5 yards behind the shooting line. There is to be no shooting until **all** persons in front of the firing line have cleared, for obvious safety reasons. The Range Master or Minister of Archery is to be sure that all have returned when retrieving arrows.
7. All bows are to remain unnocked until Range Master or Minister of Archery has given the ok to shoot. Only then may the arrows be placed on the bowstring.
8. Shooting in an unsafe manner is grounds for removal from the archery lists for up to 12 months (see the Adrian Empire Archery Manual). This includes, but is not limited to, the following:
 - Shooting a target arrow at someone
 - Aiming a bow with a target arrow at someone
 - Shooting an arrow into the air to see “**how high**” it will shoot, etc.
9. A Range Master or Minister of Archery is to be present at all times when target archery is taking place.
10. Each person should supply their own equipment and is responsible for the upkeep and frequent condition checks for safety (cracked arrow shafts, cracked bow limb, fraying or damaged string, etc.)

If we keep the sport safe it will remain fun for all!

College of Arms: Restructure

During the remaining days of Sir Nigels we felt it improper to speak of changing over the heraldry offices. All of our hopes were that he would recover and we felt it self defeating to speak about this office without him.

However, now in our darkest hour, we must face that Sir Nigle shall not be here physically to help us. Therefore, we must address the issue of how the enormous task of approving and storing heraldry continue. We hope that Sir Nigel's spirit shall light our way.

Many knights and commoners alike have offered their assistance in this task and for that we thank them. We shall use all of our resources to expand on Sir Nigels original dream of the collage of Heraldry. We shall have several people within the college help.

First, local sovereigns will be asked to improve their knowledge of heraldry for the approval process. The more the local heralds know the better they can weed out unacceptable heraldry at the start of the process. These are the people who need to decide if the presentation is true heraldry. This process is decreed to take no more than 30 days.

Second, when a local herald finds a piece of heraldry acceptable, they should forward it to a regional officer for conflict checking amongst other subdivisions. These officers, whose titles shall be decided by the College, are in charge of comparing arms between regions only. They are not to decide upon the presentation of the heraldry. This process is decreed to take no more than 15 days. These regional officers shall be announced shortly.

Third, the coastal deputies are to watchdog the regional officers. If the coastal deputy feels that a regional officer is behind or not doing their job, they shall order the local Sovereigns to redirect their submission to a different regional officer until they are current. These coastal deputies are Sir Karl (Brandenburg) and Sir Ian (Kildare).

Fourth, if found not to be in conflict by a regional officer, the heraldry shall be sent to both the Heraldry Archiver and Earl Marshal of Heraldry.

Fifth, the Earl Marshal of Heraldry shall review the submission for rejection due to presentation. The job of the Earl Marshal is to catch improper blazons and presentations. If the Earl Marshal feels the heraldry is improper, then he may strike it upon notice. This notice must be delivered within two weeks of his receipt and be sent to the local Sovereign and the Archiver. If not rejected within the two weeks, the heraldry shall be considered approved and registered. The Earl Marshall shall be named shortly.

Sixth, upon not receiving a reject letter, within two weeks of receipt the archiver shall file the record in a physical case. He shall make electronic copies and update an electronic armorial. He shall make this armorial public.

The archiver shall be Le Bet'e de Acmd (York). This process may take no longer than 1 week.

We recognize this process has many steps. We find this is a strength. For if any part of this process fails the system will still work through redirection. This is a system of rejection by notice. Therefore, without a rejection there is acceptance. Ministers falling behind or being unreachable shall be replaced, and the worst case scenario is bad heraldry will only be restricted to one person. Let us pray the collage does it's job and no minister falls too far behind.

The Archivist has been previously announced, and has been working diligently. We have been informed that a release of the project to date will be ready in the immediate future. Thank you to Le Bet'e de Acmd of York for his work to date.

The Earl Marshall is Sir Alaric Thorne of Castilles. He worked diligently for Us once before, and has volunteered to work on the project again in this new capacity.

The position of Historian was not previously announced, but upon review, we have determined this is of utter necessity. Sir Gregoire d'Avallon of Esperance will be in charge of assisting with appeals based on historical evidence, as well as providing valuable historical expertise to the decisions and advancement of the college.

The coastal duputies remain Sir Ian of Kildare and Sir Karl of Brandenburg. The regional deputies are as follows:

- For all CA subdivisions, we ask Lord Cledwyn of TN,
- For all SE subdivisions, we ask Giacamo of Castilles,
- For all NE subdivisions, and Alhambra, we ask Sir Guillaume of Alhambra,
- And for all Middle Adria, Aragon, Albion, and Umbria, we ask Sir Valance Prize of Umbria, to review submissions for conflict across the Empire.

Aside from being a forum for the dissemination of knowledge, we hoped to be able to interest our "guests" in becoming members in one of the divisions of the Duchy.

Greetings;

I wanted to send this out today to let everyone know just how pleased I was with how things went in our "First Annual Academy of St. Adrian's School of Cavalry" yesterday. First and foremost, no one got hurt. That is always a big plus for any event involving horses, especially when most of the horses and riders are unfamiliar with not only each other, but with virtually all of the other horses and riders involved. Secondly, I think that everyone had a good time, which is almost as important to me (but not quite!) Third, I think that all of our students, taking part both mounted and dismounted, were able to go away with some new knowledge under their belt, and will be able to use that knowledge to their benefit, whether it be in the realm of living history, writing, or just being able to say "Heck, I was there, and this is how we did it!"

We were able to engage in a classroom session in the morning in which we discussed much of the history of Cavalry in the Sixteenth Century, and why the weapons and tactics changed so much during that century. Then we were off to mount up and do some basic drills for a few hours prior to lunch just to get both our minds, as well as (and perhaps more importantly) the horses' minds used to the ideas that we were going to implement in the afternoon.

I wish to thank each and every one of our participants and staff for making this happen. We had participation from about as broad an area of historical interest in horse cavalry as you can get. We had Hennessy Knoop join us, who's main area of interest is in Roman and Persian heavy Cataphract cavalry; Henrik Olsgaard, definitely one of the "old hands" at this, who's interest lies in the era of the Norman Conquest (and who kindly supplied us with the use of his quintain, as well as bringing out a variety of lances to show to the class. His wearing of the breastplate for drill with the lance rest on it was a great touch!); on up to Ann Dutson, who's interest is in the American Civil War, Fred Klink wearing his Indian Wars uniform and accoutrements, and Gerry Bowen in his US Army ca. 1942 rig. The participants ranged from members of the Society for Creative Anachronism, to the National Civil War Association, the California Historical Group (WWII) and of course the numerous members of the Renaissance Military Society.

For those of you who weren't able to join us yesterday for the event, I want to welcome you to plan in the future to be with us to learn, ride, and enjoy the intoxicating realm of Cavalry.

All of these issues have been handled with the utmost care, and, We believe, to the satisfaction of all involved. These issues have been very time consuming and have taken up a large part of the first six months of Our reign.

We have seen growth in the Empire through the increase in membership at the Imperial Stewards office. The Imperial Hospitler has helped in the creation of the new subdivision of Nassau and the return of Neu Eisenwold. We personally have addressed tremendous conflict within Aragon and saved many members of the Empire with the creation of Albion, providing the needed breathing room for a large, congested populace. Galloway, Kildare and Gloucester (Fire & Ice) have also all been feeling renewed growth and spirits. None of our subdivisions are currently below the proper numbers for their current statuses. We also have several promising new leads for new subdivisions in several other states including Pennsylvania, Texas, Kansas and Mississippi.

Several new manuals are in the works (and almost authorized). These include a New Subdivision Guide, New Crown Guide, Physicker's Guide, and Dictionary of Terms. Updates to the Combat Manual are ongoing.

The Chancellery has been expanded, and efficiency has been increased. Our last Imperial estates meeting, which had a large workload, finished in record time. The presentation of the populace at estates meetings has also been addressed.

The Office of Publishing has been working in overdrive and the website has a new look. An additional publication was released containing many articles that were unable to be included in prior heralds.
