ORDER OF THE FLEUR DE LIS



The Imperial Order of the Fleur-de-Lis

This Order was formerly known as the Order of the Protectors of the Dream. This Order is intended to honor those individuals whose contributions to the Empire are so great that they are deserving of being made members of the Imperial Family, but have not necessarily sat the Imperial Throne themselves. Members are appointed by a simple majority vote of the Imperial Estates and are invested with their titles by the Imperial Crown.

Members of this Order have the following rights and privileges:

- a. New members may be nominated from within the Order or by two members of the Imperial Estates. Any member of the Empire is eligible for admittance, whether they have been a past Imperial Crown or not.
- b. Members are appointed by a simple majority vote of the Imperial Estates and are invested with their titles by the Imperial Crown
- c. This Order grants no vote on any Estate, although individual members of this Order may hold Estate Votes of their own right.
- d. Companions of this Order have precedence as members of the Imperial Family, may use the courtesy title of Prince/ss, may be addressed as "Your Imperial Highness", and may wear a Coronet.
- e. Like any other person, Companions of this Order may nominate for the titles of Lord/Lady and Baron/ess for Imperial and Royal awards. However, as a special privilege of the Order, if the Local or Imperial Crown approves the nomination, the nominating member of the Order shall bestow the title.
- f. Companions of this Order may sit with Imperial Crowns as Peers and may approach them without bowing.

Crown Writ Rawlings

It was presented to the Empire that we felt the generic term in our manual of the blanket statement of "Rawlings type Sword", as the quantifier for authorized weapon use was inadequate. One, it eliminated any other manufacturer as well as did not take into account future modifications that could be made by the Rawlings manufacturer such as increased stiffness and metal parts.

We called for a Knight's workshop to create a minimal standard to judge acceptable synthetic waster use.

- Blade material: Nylon plastic
- Max weight allowed 2 lbs (32 Oz - 907 grams)
- Minimum of 4.5" (11.4 cm) tip flex with 2 lb (907 gram) weight added
- No metal fittings or attachments (including quillian and pommel)
- No sharp edges - all flashing must be removed
- Only commercially available attachments (cross guards, basket hilts, pommels etc) Any homemade or custom parts must be individually approved by the Imperial Minister of Joust and War

- **RIGID ADHERENCE TO ARTICLE III C.3.A.B OF THE COMBAT MANUAL**
- **REPORTING MUST BE DONE WITHIN TWO WEEKS OF EVENT TO CADERIVI@AOL.COM. REPORTS SHALL INCLUDE THE NAMES OF THE COMBATANTS TESTING AND THEIR STATEMENTS OF EXPERIENCE.**
- **FAILURE TO REPORT WILL RESCIND PLAYTEST ABILITY FOR THE CHAPTER**

PLAY TEST WILL END SEPTEMBER 1, 2017. ALL REPORTS SHALL HAVE BEEN REPORTED. WE SHALL COMPILE THE INFORMATION AND MAKE REPORT AND RECOMMENDATION TO THE IMPERIAL ESTATES IN NOVEMBER 2017.

Primary Reporting

Upon evaluation we have come to the realization that Primary reporting has become extremely lax, with over half of the Empire either not understanding their responsibilities or taken a laze faire attitude. By Primary Reporting we mean;

Crown Report: "Mundane Chapter President and Vice President.

Stewards Report: Mundane Chapter Treasurer

Rolls Minister: Mundane Clerk of Records

There are many reasons for this and as being previous chapter crowns we are well aware of the obstacles that take place in a volunteer organization. It's not easy. We are also open to hearing from crowns as to how we can better support them in making the processes more efficient or easier to complete. Yet the basic fact is these Primary reports are too darn important to the operations of this organization that we all need to take a step back and realize that these three things are what make us an "Organization".

We are putting these policies in to place for our tenor. We hope we can show the Estates that this is really just a level of responsibility of an organization and consider adapting them as regular policy.

The Primary Reports,

- Due 30 days following an event (Example; Crown event is December 10th, all chapter events leading up to December 10 will be included in the report for the December 10, event. November 11 thru Dec 10 = report due by January 10. Simplest terms; we want to know what happened leading up to your event and what happened at event.
- We will call the Crowns when these reports are delinquent one month.
- In the Stewards office, two months delinquency without prior approval From the Imperial Crown, will result in Judicial Ban of the Chapter Crowns until such a time as all reporting is brought current. (Mundanely speaking: We will suspend chapter activities until said chapter fulfills its responsibilities)
- Primary Reporting is Due every month (regardless of event combinations, cancelled events, paper hungry dogs etc..

Auxiliary Reporting

We wish to shift the paradigm of some of the Imperial Ministers roles within the organization. We believe the communication should be a two way Street.

- ❖ In the areas of safety it is without exception that local chapters shall report to their Imperial counterpart.

In the ministries of the Chivalry, Combat, Archery and Arts, We need not another report saying "nothing" nor do we need information without purpose. So unless there is specific instruction issued by the imperial government or you are involved in some activity which requires written reports such as play testing, or war results, we will not hound you for reporting.

We would ask though to consider providing some form of written educational in its place for publishing. If you wish to garner D.I.s at the status of an Imperial Minister they will be issued at the rate of 1 DI for every two months of educational service. (Though all may not be published, all will be granted after review and acceptance of the Imperial Crown).

For the Chivalry of Ministry, many of your offices are based around reporting, and essential to the operations of the Empire. So unfortunately we cannot be as casual here. Yet we will hold the same option open for the extra educational service.

As for Imperial Ministers, they shall earn their monthly Di's by reporting to you. Either by outreach communication such as reviewing and educating in rules and practice (please see the Yahoo rolls board, Dame Katelyn is doing an excellent job. I have been watching and think it's a great way to bring together thoughts and experience), or providing educational publications in a variety of interests.

It is also their job to inform each chapter directly of changes in law and policy for their area of service, once they take place.

\$ 3.00 per child (6 to 12)



Please insure your combat tests have been posted as this will save time as well.





Keep Your Artist Happy



The Last Judgment is a fresco by the Italian Renaissance master Michelangelo executed on the altar wall of the Sistine Chapel in Vatican City. It is a depiction of the Second Coming of Christ and the judgment by God of all humanity. The souls of humans rise and descend to their fates, as judged by Christ surrounded by prominent saints.



The work took four years to complete and was done between 1536 and 1541, this was twenty five years after he finished the Sistine Chapel ceiling. Michelangelo originally accepted the commission for this important painting from Pope Clement VII. The original subject agreed upon for the mural was the resurrection, but this Pope's died and his successor, Pope Paul III, felt the Last Judgment was a more fitting subject. While traditional medieval last judgment paintings showed figures dressed according to their social positions, Michelangelo created a new standard. His painting shows figures equalized in their nudity, stripped bare of rank? and sometimes even their skin.





The Pope's Master of Ceremonies Biagio da Cesena said of the painting "it was disgraceful that in so sacred a place there should have been depicted all those nude figures, exposing themselves so shamefully," and that it only belonged in "the public baths and taverns."

Michelangelo worked Cesena into the scene as Minos, judge of hell, (far bottom-right corner of the painting) with Donkey ears (indicating foolishness), and with his nudity "covered" by a snake. It is said that when Cesena complained, the Pope joked that his jurisdiction was only heavenly and did not extend to hell, so the likeness of Cesena would have to remain. Since 1541 Cesena has been infamous for being painted so vividly by Michelangelo.

The moral of the story, do NOT anger the artist!

BIRDS IN HERALDRY



Greetings unto the College of Arms of the Adrian Empire and all other interested persons.

The topic this month is part one of a series on the subject of birds in heraldry. Typically, in Adria we divide birds into three types:

Raptors, ie eagles, falcons, ospreys and the like

Birds with unique postures, ie pelicans in their piety, peacocks in their pride, herons

All other birds, ie the several kinds of blackbirds, choughs, martlets, swallows, etc.

This article will be about Raptors, including how they were drawn in period.



We will begin with the eagle, a very common bird in heraldry, particularly continental heraldry. The most common posture for eagles was displayed. Arthur Charles Fox-Davies, a famous figure in heraldic research circles that many of you are familiar with, notes in his Complete Guide to Heraldry that “Though the earliest rolls of arms give us instances of various other birds, the bird which makes the most prominent appearance is the Eagle, and in all early representations this will invariably be found "displayed.”

Displayed eagles can also be double or even triple headed. While there are theories that the double headed eagle may have come from marshalled arms originally, it actually predates the use of heraldry by a good bit.

The details of how eagles are drawn in heraldry changes with time period in country – earlier depictions include curled sections on the top of the wings, for example. The tail feathers change, the tongue may or may not stick out, the claws typically will be red for some times and match the bird for others. Some are shown with their wings elevated, the classic image of a displayed eagle, as in our example, while others have their wings “inverted”.

It should be noted that wing position is considered cosmetic in Adrian Heraldry, much like the head position of a lion. While they are important to describing the bird, a change in wing position is not enough for a CD for conflict checking.



The other possible postures for eagles are close, volant and rising. While we allow eagles in the close posture, typically in period, eagles were displayed or rising, while falcons and hawks were close. (There is some disagreement about this point. Since eagles and falcons are the same bird for most heraldic purposes, it is largely immaterial which one is chosen.)

There are a variety of wing positions for rising, but again, all rising eagles are in the same posture for conflict checking.



Parts of an eagle may also be used, including the head, wings (single or double), and leg with claw.



From Fox Davies, *A Complete Guide to Heraldry*, plus perhaps an eagle's leg from a 15th century English roll of arms.

That's my own identification, so it could always be a tree or something completely different, but I think it's a leg.

What other raptors are there? There are falcons and hawks (primarily called hawks only for purpose of canting), ospreys (white eagles), vultures (rare) and alerions. The last are legless and sometimes beakless eagles, primarily shown in the arms of the Duchy and House of Lorraine – alerion is an anagram of Lorraine:



Achievement of the House of Lorraine, 1890. Also shows some lovely diapering. The crest is a white eagle, versus the white alerion on the arms themselves.

What is the difference between a falcon/hawk and eagle besides the typical posture? Falcons are also frequently shown as “belled” or jessed, on one or both legs. They may also be shown as hooded.
