PROCEDURE FOR HANDLING A MAIN MOTION

NOTE: Nothing goes to discussion without a motion being on the floor.

Obtaining and assigning the floor#

A member raises hand when no one else has the floor

• The Chancellor recognizes the member by name

How the Motion is Brought Before the Estates#

- The member makes the motion: I move that (or "to") ... and resumes his seat.
- Another member seconds the motion: I second the motion or I second it or second.
- The Chancellor states the motion: It is moved and seconded that ... Are you ready for the question?

Consideration of the Motion#

- 1. Members can debate the motion.
- 2. Before speaking in debate, members obtain the floor.
- 3. The maker of the motion has first right to the floor if he claims it properly
- 4. Debate must be confined to the merits of the motion.
- 5. Debate can be closed only by order of the assembly (2/3 vote) or by the Chancellor if no one seeks the floor for further debate.

The Chancellor puts the motion to a vote#

- 1. The Chancellor asks: *Are you ready for the question?* If no one rises to claim the floor, the Chancellor proceeds to take the vote.
- 2. The Chancellor says: The question is on the adoption of the motion that ... As many as are in favor, say 'Aye'. (Pause for response.) Those opposed, say 'Nay'. (Pause for response.) Those abstained please say 'Aye'.

The Chancellor announces the result of the vote.#

- 1. The ayes have it, the motion carries, and ... (indicating the effect of the vote) or
- 2. The nays have it and the motion fails

WHEN DEBATING YOUR MOTIONS

- 1. Listen to the other side
- 2. Focus on issues, not personalities
- 3. Avoid questioning motives
- 4. Be polite



HOW TO ACCOMPLISH WHAT YOU WANT TO DO IN MEETINGS

MAIN MOTION#

You want to propose a new idea or action for the group.

- After recognition, make a main motion.
- Member: "Madame Chancellor, I move that_____."

AMENDING A MOTION#

You want to change some of the wording that is being discussed.

- After recognition, "Madame Chancellor, I move that the motion be amended by adding the following words______."
- After recognition, "Madame Chancellor, I move that the motion be amended by striking out the following words______."
- After recognition, "Madame Chancellor, I move that the motion be amended by striking out the following words,__, and adding in their place the following words__."

REFER TO A COMMITTEE#

You feel that an idea or proposal being discussed needs more study and investigation.

 After recognition, "Madame Chancellor, I move that the question be referred to a committee made up of members Smith, Jones and Brown."

POSTPONE DEFINITELY#

You want the membership to have more time to consider the question under discussion and you want to postpone it to a definite time or day, and have it come up for further consideration.

After recognition, "Madame Chancellor, I move to postpone the question until

PREVIOUS QUESTION#

You think discussion has gone on for too long and you want to stop discussion and vote.

After recognition, "Madam Chancellor, I move the previous question."

LIMIT DEBATE#

You think discussion is getting long, but you want to give a reasonable length of time for consideration of the question.

After recognition, "Madam Chancellor, I move to limit discussion to two minutes per speaker."



HOW TO ACCOMPLISH WHAT YOU WANT TO DO IN MEETINGS cont.

POSTPONE INDEFINITELY#

You want to kill a motion that is being discussed.

After recognition, "Madam Chancellor, I move to postpone the question indefinitely."

POSTPONE INDEFINITELY#

You are against a motion just proposed and want to learn who is for and who is against the motion.

• After recognition, "Madame Chancellor, I move to postpone the motion indefinitely."

RECESS#

You want to take a break for a while.

After recognition, "Madame Chancellor, I move to recess for ten minutes."

ADJOURNMENT#

You want the meeting to end.

After recognition, "Madame Chancellor, I move to adjourn."

PERMISSION TO WITHDRAW A MOTION#

You have made a motion and after discussion, are sorry you made it.

• After recognition, "Madam President, I ask permission to withdraw my motion."

CALL FOR ORDERS OF THE DAY#

At the beginning of the meeting, the agenda was adopted. The Chancellor is not following the order of the approved agenda.

Without recognition, "Call for orders of the day."

SUSPENDING THE RULES#

The agenda has been approved and as the meeting progressed, it became obvious that an item you are interested in will not come up before adjournment.

After recognition, "Madam Chancellor, I move to suspend the rules and move item 5 to position 2."

POINT OF PERSONAL PRIVILEGE#

The noise outside the meeting has become so great that you are having trouble hearing.

- Without recognition, "Point of personal privilege."
- Chancellor: "State your point."

Member: "There is too much noise, I can't hear."



HOW TO ACCOMPLISH WHAT YOU WANT TO DO IN MEETINGS cont.

COMMITTEE OF THE WHOLE#

You are going to propose a question that is likely to be controversial and you feel that some of the members will try to kill it by various maneuvers. Also you want to keep out visitors and the press.

• After recognition, "Madame Chancellor, I move that we go into a committee of the whole."

POINT OF ORDER#

It is obvious that the meeting is not following proper rules.

• Without recognition, "I rise to a point of order," or "Point of order."

POINT OF INFORMATION#

You are wondering about some of the facts under discussion, such as the balance in the treasury when expenditures are being discussed.

Without recognition, "Point of information."

POINT OF PARLIAMENTARY INQUIRY#

You are confused about some of the parliamentary rules.

Without recognition, "Point of parliamentary inquiry." APPEAL FROM

THE DECISION OF THE CHANCELLOR Without recognition, "I appeal from

the decision of the Chancellor."

How Adria Works By Dame Katelyn

Dame Katelyn again. Time to bend your ear and share a bit with you. It never fails to surprise me, the number of members who come to play, but don't really understand what we are about. The structure of the organization, the "officers", the policies, protocol, the manners, the titles, customs and habits.

Excuse me if this is old hat news for you. There are a lot of folks out there who will hopefully benefit. Adria is divided into chartered subdivisions, each with their own specific geographic borders. You are a member of the chartered subdivision where you physically live for the majority of the year. There are some exceptions to this. There are 5 main types of subdivisions, and they are determined by the number of members in that group.

Of course, we would begin with the Empire. This encompasses all of us. The Crown, or ruler, would be the Emperor/Empress. This is followed by a Kingdom, 100 or more ruled by a King/Queen; Archduchy, 50 members or more ruled by an Archduke/Archduchess; Duchy, 20 or more ruled by a Duke/Duchess and finally a Shire which is ruled by a Viceroy/Vicerine and only requires 5 members. There is another type of subdivision which is called a Canton. This is a long distance subdivision with assigned Deputy Ministers to help it run smoothly.

Within those chartered subdivisions, there are also "estates". You may remain an independent member of the subdivision. If you choose, you may join, or even form, an Estate. As with subdivisions, Estates are determined by the number of members. They are as follows: House, 5 or more members headed by a Lord/Lady; Barony 15 members headed by a Baron/Baroness; County, 35 members headed by a Count/Countess and a March, consisting of 50 members headed by a Marquis/Marquessa. You may hear someone refer to "unlanded estates". Second and Third level Knights and retired Crowns are awarded that consideration.

While we all want to have fun, we are a re-creation group. A certain amount of respect and decorum should be followed. There are a few basic points I would like to address. The opening or closing ceremony of our events is called Court. During this time, announcements, important and fun information is presented. Conversing in a normal tone of voice with your neighbor would be extremely rude. If you should be called upon to address the populace or approach the Crown during Court, keep the following in mind. All weapons are to be removed and left behind. A reverential bow and kneeling before the Crown is the standard procedure.

Immediately step aside so that you are not blocking the Crown. When you have finished, turn to face the Crown, bow again and walk backward a few steps. You may then turn and return to your seat. It is considered quite rude to turn your back on a Crown. In passing, if you should encounter the Emperor, Empress, King or Queen you would make a courteous bow or curtsey. Be careful that you do not block the view of any of these people. Also, keep in mind that approaching your Crown with a slap on the back and the query "how's it hanging?" may be enough to get you slapped in irons and share the dungeon with the kingdom rats.

All members of Adria are nobles. While nobles do not have the title of Lord or Lady, that particular form of address may be used as a courtesy when addressing an individual. This is somewhat like the modern day Ma'am, Sir, Lady, Mr., Mrs. or Miss.

There are titled nobles in Adria. It can get extremely confusing to remember the proper form of address. If you can't remember, or don't know, don't worry. A simple and polite My Lady or My Lord will do. No one should be offended if you ask them how to properly address them. Looking at what someone is wearing as far as a crown, coronet, circlet or particular color of belt can give you assistance. But that does not always hold true. Many dress very simply and without the accoutrements of their station.

Some simple tricks to help remember - If they are wearing a crown, you can't go wrong with "Your Excellency." If they are sitting on a Throne, "Your Grace" works wonderfully.

Whether addressing someone in person, in a letter or on an email list, the same courtesies, respect and titles would apply. Something else to keep in mind. Whether you like an individual or not, we are not a democracy. Respect for the station and accomplishments should be shown at all times.

In addition to the listing I have attached, there are a few more to keep in mind. The Order of the Fleur-de-Lis was created to honor individuals who have contributed greatly to the Empire. These people have not served as Imperial rulers. They are voted upon by the Imperial Estates General. These individuals are accorded the benefit of membership in the Imperial Family. They are accorded the courtesy title of Prince or Princess, may be addressed as "Your Imperial Highness", and may wear a coronet.

The Imperial Crown Prince and Imperial Crown Princess are the Heirs to the Empire. When addressing them, you may insert Imperial in front of Highness. The Crown Prince and Crown Princess are the Heirs to the Kingdom. If you should so choose, you may insert Royal in front of Highness.

A retired Emperor or Empress retains the title of Prince or Princess. They may be addressed as Your Highness.
